Invitation to Bid for the supply & delivery of Various Office Supplies & Equipment for use of different offices of Batangas City Government

The Batangas City Government intends to apply the sum of Php 632,240.80 being the Approved Budget for the Contract to payments under the contract for BAC-PG-00144-20. Bids received in excess of the ABC shall be automatically rejected at Bid Opening.

The Batangas City Government now invites bids for the supply & delivery of Various Office Supplies & Equipment for use of different offices of Batangas City Government. Delivered of the Goods is required within 15 calendar days upon contract signing. Bidders should have completed, within 2 years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grants similar rights or privileges to Filipino citizens, pursuant to RA 5183.

Interested Bidders may obtain further information from the Batangas City Government and inspect the Bidding Documents at the address given below from 8:00 a.m. to 5:00 p.m.

A complete set of Bidding Documents may be acquired by interested Bidders on July 07, 2020 at 8:30 a.m. from the address below and upon payment of a non-refundable fee in the amount of Php 1,000.00.

Bids must be duly received by the BAC Secretariat at the address below on or before July 14, 2020 at 08:30 a.m. All bids must be accompanied by a Bid Security in any of the following form:

Bid Opening shall be on July 14, 2020 at 09:00 a.m. at the Office of the BAC Secretariat/TWG-PG, Batangas City. Bids will be opened in the presence of the Bidder's representatives who choose to attend at the address below. Late Bids shall not be accepted.

The City Government of Batangas reserves the right to reject any and all bids, declare a failure of bidding or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
