The Batangas City Government intends to apply the sum of Php 372,888.00 being the Approved Budget for the Contract to payments under the contract for BAC-PG-240-23. Bids received in excess of the ABC shall be automatically rejected at Bid Opening.

The Batangas City Government now invites bids for the supply & delivery of Various Office Supplies for use of Sangguniang Panlungsod ng Batangas. Delivery of the Goods is required within 7 calendar days upon contract signing. Bidders should have completed, within 2 years from the date of submission and receipt of bids, a contract similar to the Project. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grants similar rights or privileges to Filipino citizens, pursuant to RA 5183.
