The contract will be awarded by lots. Bids received in excess of the corresponding ABC per lot shall be automatically rejected at bid opening. Partial Bidding is allowed.

The Batangas City Government now invites bids for the supply & delivery of Various Medicines for use of the City Health Office. Delivery of the Goods is required within <u>10 calendar days</u> upon contract signing. Bidders should have completed, within 1 year from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grants similar rights or privileges to Filipino citizens, pursuant to RA 5183.
