The Batangas City Government intends to apply the sum of Php 862,175.00 being the Approved Budget for the Contract to payments under the contract for BAC-PG-426-23. Bids received in excess of the ABC shall be automatically rejected at Bid Opening.

The Batangas City Government now invites bids for the supply & delivery of Various Maintenance Materials for use of different offices of Batangas City Government. Delivery of the Goods is required within <u>7 calendar</u> <u>days</u> upon contract signing. Bidders should have completed, within 2 years from the date of submission and receipt of bids, a contract similar to the Project. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grants similar rights or privileges to Filipino citizens, pursuant to RA 5183.
