The Batangas City Government now invites bids for the supply & delivery of Various Motor vehicles for use of Batangas City Government. Delivery of the Goods is required within <u>10 calendar days</u> upon contract signing. Bidders should have completed, within 1 year from the date of submission and receipt of bids, a contract similar to the Project.
