The Batangas City Government now invites bids for the supply & delivery of Meals & Snacks for use of Batangas City Government. Delivery of the Goods is required within <u>7 calendar days</u> upon contract signing. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grants similar rights or privileges to Filipino citizens, pursuant to RA 5183.
