Bids received in excess of Budget for the Contract shall be automatically rejected at Bid Opening.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grants similar rights or privileges to Filipino citizens, pursuant to RA 5183.

Only those who have purchased the Bidding Documents shall be allowed to participate in the Pre-bid Conference.
