The Batangas City Government intends to apply the sum of Php 200,000.00 being the Approved Budget for the Contract to payments under the contract for BAC-PG-00010-24. Bids received in excess of the ABC shall be automatically rejected at Bid Opening.

The Batangas City Government now invites bids for the supply & delivery of Meals & Snacks for use of Sangguniang Panlungsod ng Batangas. Delivery of the Goods is required within <u>7 calendar days</u> upon contract signing. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grants similar rights or privileges to Filipino citizens, pursuant to RA 5183.
