REQUEST FOR EXPRESSION OF INTEREST FOR
CONSULTANCY SERVICES FOR THE PREPARATION OF COMPREHENSIVE URBAN DRAINAGE
AND SEWER/SEWERAGE MASTER PLAN FOR BATANGAS CITY

1. The Batangas City Government through the City Disaster Risk Reduction Management Office Fund (Trust Fund CY 2021) intends to apply the sum of THIRTEEN MILLION PESOS (Php13,000,000.00) being the Approved Budget Cost (ABC) for the Contract to payment under the contract for CONSULTANCY SERVICES FOR THE PREPARATION OF COMPREHENSIVE URBAN DRAINAGE AND SEWER/SEWERAGE MASTER PLAN FOR BATANGAS CITY. Bids received in excess of the ABC shall be automatically rejected at the opening of the financial proposals.
2. The Batangas City Government Bids and Awards Committee now call for the submission of eligibility documents for Consultancy Services for the Preparation of Comprehensive Urban Drainage and Sewer/Sewerage Master Plan for Batangas City. Eligibility documents of interested consultants must be received by the BAC Secretariat on or before August 16, 2021 at the BAC Secretariat, City Planning and Development Office, City Hall Annex Building, P. Burgos Street, Batangas City.
3. Interested bidders may obtain further information from Batangas City Government and inspect the Bidding Documents at the address given below during government office hours.
4. A complete set of Bidding documents may be acquired by interested short-listed bidders from the address below upon the applicable fee for Bidding Documents, pursuant the latest guidelines issued by the GPPB in the amount of TWENTY FIVE THOUSAND PESOS (Php 25,000.00).
5. The BAC shall draw up the short list of consultants from those who have submitted Expression of Interest, including eligibility documents and have been determined as eligible in accordance with the provisions of Republic Act 9184. Otherwise known as "Government Procurement Act" and its Implementing Rules and Regulations (IRR). The short list shall consist of three (3) prospective bidders who will be entitled to submit bids. The criteria and rating system for short listing are:

	Criteria/Particulars	Rating
1	Experience and Capability of the Firm	60%
2	Quality of Personnel	30%
3	Current Workload Relative to Capacity	10%

6. Bidding will be conducted through open competitive procedure using non-discretionary "pass/fail" criterion as specified in RA 9184.


7. The Procuring Entity shall evaluate bids using the "Quality Base Evaluation/Selection (QBE/QBS) procedure.
8. The contract shall be completed within THREE HUNDRED SIXTY (360) working days.
9. The Batangas City Government reserves the right to reject any and all the bids, declare failure of bidding or not award the contract at any time prior to contract award in accordance with Sec. 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder/bidders.
