**ORDINANCE NO. 6 S. 2013**

**AN ORDINANCE APPROPRIATING THE AMOUNT OF SEVENTEEN MILLION FOUR HUNDRED SIXTY EIGHT THOUSAND SEVEN HUNDRED THIRTY THREE PESOS AND FIFTY TWO CENTAVOS (P17,468,733.52) FOR THE SUPPLEMENTAL BUDGET NO. 2 OF THE CITY GOVERNMENT OF BATANGAS FOR THE CALENDAR YEAR 2013**

**WHEREAS**, on August 2, 2013 the Honorable City Mayor Eduardo B. Dimacuha submitted to the Sangguniang Panlungsod the proposed Supplemental Budget No. 2 of the City Government of Batangas for Calendar Year 2013 amounting to P17,468,733.52 for legislation and authorization.

**WHEREAS**, the funding sources for the Supplemental Budget No. 2 of the City Government comes from the share from PAGCOR/PCSO Calendar Year 2008 for the period January to June, 2012, miscellaneous income-prior year's adjustment 684, savings from various accounts of different offices, savings from the continuing and current capital outlays, and savings from the 20% Community Development Fund which are free from any obligation or encumbrance.

**WHEREAS**, an examination and analysis of the documentary requirements, the program of appropriations, the objects of expenditures show no legal impediment for the approval of the Supplemental Budget No. 2 of the City Government of Batangas.

**WHEREAS**, the approval of the Supplemental Budget No. 2 is in accordance with the Supplemental Annual Investment Program No. 2 of the City Government for Fiscal Year 2013.

**BE IT ORDAINED BY THE SANGGUNIANG PANLUNGSOD OF BATANGAS CITY THAT:**

**SECTION 1. TITLE** – This Ordinance shall be known and cited as the “Supplemental Budget No. 2 of the City Government of Batangas for the Calendar Year 2013”.

**SECTION 2. APPROPRIATION OF FUNDS.** – There is hereby appropriated from the General Fund of the City Treasury the amount of Seventeen Million Four Hundred Sixty Eight Thousand Seven Hundred Thirty Three Pesos and Fifty Two Centavos (P17,468,733.52) from the share from PAGCOR/PCSO CY 2008 for the period January to June, 2012, miscellaneous income-prior year's adjustment 684, savings from various accounts of different offices, savings from the continuing and current capital outlays, and savings from the 20% Community Development Fund which are free from any obligation or encumbrance as certified by the Local Finance Committee, and which are available for Supplemental Appropriation in accordance with the Objects of Expenditure as enumerated in the statement of Supplemental Appropriation (LBP Form No. 10).

Continuation of Ordinance No. 6 S. 2013

**AN ORDINANCE APPROPRIATING THE AMOUNT OF SEVENTEEN MILLION FOUR HUNDRED SIXTY EIGHT THOUSAND SEVEN HUNDRED THIRTY THREE PESOS AND FIFTY TWO CENTAVOS (P17,468,733.52) FOR THE SUPPLEMENTAL BUDGET NO. 2 OF THE CITY GOVERNMENT OF BATANGAS FOR THE CALENDAR YEAR 2013**

**SECTION 3. COMPLIANCE**

- 3.1 Any change in the budget shall be in accordance with the provision of Section 321 of the Local Government Code of 1991.
- 3.2 Disbursement and expenditures shall comply with the budgetary requirements and limitations provided in Section 324 and Section 325 of R.A. 7160 and all accounting and auditing rules and regulations.
- 3.3 Compliance to DILG Memorandum Circular No. 2011 - 134 dated September 19, 2011 on full disclosure of local budget and finance, bids and public offerings.
- 3.4 Compliance to Section 22, 26 and 27 of R.A. 7160 required

**SECTION 4. REPEALING CLAUSE.** - All ordinances, rules and regulations, orders or parts thereof which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

**SECTION 5. SEPARABILITY CLAUSE.** - If for any reason any part of this ordinance shall be held unconstitutional or invalid, other parts hereof which are not affected shall continue to be in full force and effects.

**SECTION 6. EFFECTIVITY.** - This Ordinance shall take effect upon approval of the City Mayor.
