ORDINANCE NO. 13 S. 2014

AUTHORIZING THE AUGMENTATION OF APPROPRIATIONS
IN THE OFFICE OF THE CITY ASSESSOR

WHEREAS, Section 336 of the Local Government Code of 1991 states:

Section 336. Use of Appropriated Funds and Savings, Funds shall be available exclusively for the specific purpose for which they have been appropriated. No ordinance shall be passed authorizing any transfer of appropriations from one item to another. However, the local chief executive or the presiding officer of the Sanggunian concerned may, by ordinance, be authorized to augment any item in the approved annual budget for the respective offices from savings and other items within the same expense class of their respective appropriations.

WHEREAS, the transfer of appropriation from one item to another is allowed when the purpose of the transfer is to augment any item in the approved annual budget within the same expense class.

NOW THEREFORE, be it ordained by the Sangguniang Panlungsod in Session assembled:

SECTION 1. TITLE. This Ordinance shall be called "Ordinance Authorizing the Augmentation of Appropriations in the Office of the City Assessor"

SECTION 2. AUGMENTATION. The augmentation in the Office of the City Assessor is hereby approved and authorized:

A) OFFICE OF THE CITY ASSESSOR

From: (751) Travelling Expenses	Php	100,000.00
(753) Training Expenses		<u>100,000.00</u>
	Php	200,000.00
To: (755) Office Supplies Expenses	Php	200,000.00

SECTION 3. AUTHORITY. The City Mayor is hereby authorized to sign all documents necessary to effectuate the Augmentation.

SECTION 4. COMPLIANCE. Compliance to all auditing rules, regulations and circulars issued by COA and the Department of Finance shall be strictly complied with by the Officials concerned.





SECTION 6. EFFECTIVITY. This Ordinance shall take effect upon approval of the City Mayor.



ACTION TAKEN ON AUGMENTATION OF APPROPRIATIONS


Finding no legal impediment for the approval of the requested augmentations, the Committee recommends the approval of request of the Honorable City Mayor.





- (b) approval of the attached ordinance exempting it from the Three-Reading Rule


