ORDINANCE NO. 9 S. 2016

AMENDING ORDINANCE NO. 30 S. 2011 ENTITLED "AN ORDINANCE CREATING
THE ANTI-DRUG ABUSE COUNCIL (ADAC) OF BATANGAS CITY
AND APPROPRIATING FUNDS THEREFOR"

WHEREAS, the Anti-Drug Abuse Council of Batangas City was created through Ordinance No. 30 S. 2011 approved on October 27, 2011 and became effective after due publication;

WHEREAS, DILG Memorandum Circular No. 98-227 dated December 2, 1998 provides for the composition of the ADAC thus:

"In Furtherance of overall government efforts to address the above-mentioned problem, all provinces, cities, municipalities and Barangays are hereby enjoined to create their Local Anti-Drug Abuse Councils, to be composed of the following:

Governor/Mayor/Punong Barangay	- Chairman
PNP Provincial/City Director/ Chief of Police	- Vice Chairman
DILG Provincial/City Director/ CLGOO/MLGOO	- Member
DECS Division Superintendent/ District Supervisor	- Member
DOJ Provincial/City Prosecutor	- Member
Provincial/City/Municipal Health Officer	- Member
Provincial/City/Municipal Social Welfare Officer	- Member
Provincial/City/Municipal Information Officer	- Member
NGO Socio-Civic Group Representative	- Member
Church Group Representative	- Member"

WHEREAS, DILG Memorandum Circular No. 99-106 dated June 22, 1999 further supplemented Memorandum Circular No. 98-227 to require the inclusion of the Provincial Vice-Governors, City Vice Mayors and Municipal Vice Mayors as members of the Provincial, City and Municipal Anti-Drug Abuse Councils respectively.

WHEREAS, Section 5 of Ordinance No. 30 S. 2011 provides that the Chairman of the ADAC of Batangas City thereby created is the City Vice Mayor and the Vice Chairman is the City Chief of Police;

**AMENDING ORDINANCE NO. 30 S. 2011 ENTITLED "AN ORDINANCE CREATING

WHEREAS, there is a need to amend Section 5 of Ordinance No. 30 S. 2011 to conform to the provision of DILG Memorandum Circular No. 98-227;

NOW THEREFORE, be it ordained by the Sangguniang Panlungsod in session assembled, to amend Ordinance No. 30 S. 2011, as follows:

SECTION 1. SHORT TITLE - This Ordinance shall be cited as "Ordinance Amending the ADAC Ordinance".

SECTION 2. AMENDMENT - Section 5 of Ordinance No. 30 S. 2011 is hereby amended to read:

SECTION 5. COMPOSITION - The Council herein created shall be composed of the following:

Chairman: City Mayor

Vice-Chairman: Chief of Police

Members:

City Vice Mayor

DILG City Director

City Schools Superintendent

City Prosecutor

City Health Officer

Chief, Public Information Office

CSWDO

City Probation and Parole Officer

President, SK

President, ABC

Representative from Socio-Civic groups

Representative from Religious Groups

Others, as may be deemed necessary

SECTION 3. REPEALING CLAUSE - All laws, executive orders and executive issuances or parts thereof inconsistent herewith are hereby deemed repealed or modified accordingly.

SECTION 4. SEPARABILITY CLAUSE - If for any reason any section or provision of this ordinance shall be declared unconstitutional or invalid, no other section or provision shall be affected thereby.


AMENDING ORDINANCE NO. 30 S. 2011 ENTITLED "AN ORDINANCE CREATING
