**AUTHORIZING THE AUGMENTATION OF APPROPRIATIONS
IN VARIOUS OFFICES**

WHEREAS, Section 336 of the Local Government Code of 1991 states:

SECTION 336. Use of Appropriated Funds and Savings. Funds shall be available exclusively for the specific purpose for which they have been appropriated. No ordinance shall be passed authorizing any transfer of appropriations from one item to another. **However, the local chief executive or the presiding officer of the sanggunian concerned may, by ordinance,** be authorized to augment any item in the approve annual budget for their respective offices from savings in other items within the **same expense class** of their respective appropriations.

WHEREAS, the transfer of appropriations from one item to another is allowed when the purpose of the transfer is to augment any item in the approved annual budget within the same expense class.

NOW THEREFORE, be it ordained by the Sangguniang Panlungsod in session assembled:

SECTION 1. TITLE. This Ordinance shall be called "Authorizing the Augmentation of Appropriations in Various Offices".

SECTION 2. AUGMENTATION. The augmentation in various offices was hereby approved and authorized:





Chair: Our Committee Hearing is from the Committee on
Appropriations regarding the augmentations of GSD,
Registrar, City Budget and Tourism. So, aside form our
guest earlier I would like to acknowledge the presence of
Ms. Leonor Garcia from our City Mayors Office I believe
representing tourism, ma'am Charisma Mojares from our
Civil Registrar Office and ma'am Oliva Borbon to represent
Civil Registrar Office also, any from GSD? So, the order
of our hearing would start first on Office of the City
Civil Registrar and then followed by the Office of the
City General Services and third Office of the City Budget
and last would be the Cultural, tourism and other related
events. Mr. Dante Mercado representing our GSD so, from
our Office of the Civil Registrar Office you have the
floor to discuss your augmentation.

Mrs. Charisma Mojares: Magandang umaga po sa kanila kay Honorable Vice Mayor Jun sa atin pong mga konsehal, sa atin pong mga department heads at sa atin pong mga kasama sa trabaho. Ako po si Mrs. Charisma Mojares, wala lamang po si Mrs. Maranan ngayon kasi na-attend po sya sa Siargao po, yun pong sa Gender Development __, Training and Workshop po. Yun pong aming nire-request po na augmentation ay para po sana dun po sa fuel, oil and lubricants dun po sa other supplies expense at saka po dun sa other maintenance and operating expenses. Dun po sa aming other supplies and expenses ito po ay nagko-constitute dun po sa painting at saka po dun sa blinds po para po dun sa amin pong tanggapan, yun po namang sa OMOE, ay yun pong pest control sana kasi ang amin pong opisina kung inyo pong nabisita na meron po kaming archive, maliit pong archive vault ang tawag po namin, andun po yung aming mga documents, ngayon ay nakita po namin na meron pong anay na, so kailangan po namin sana na magawan po ng solusyon dun kasi ang hawak po namin ay mga original documents, Civil Registry Documents tsaka po meron din pong kahit ahh...hindi po namin maiwasan na meron pong mga daga. So, kailangan po talaga dahil hindi po namin makaya na dun lang sa mga fly traps o yung simple na mga sprays kasi andun din po na iniisip namin yung kapakanan po ng aming staff kasi lagi po silang labas masok po dun sa loob so kailangan po namin yun pong epektibong pest control at saka na safe din po para po sa amin pong mga sa staff. So, yun po.

Chair: Thank you ma'am, so other any ahhh, Councilor Hamilton.

Coun. Hamilton Blanco: Thank you Mr. Chair, ma'am sa katoninayan ho wala po akong masasabi sa inire-request nyo po sa Sangguniang Panlungsod ang sa akin laang ho ma'am, to Engr. Godoy. Ma'am ilan ho ang empleyado nyo sa Civil Registrar?

Mrs. Charisma Mojares: Right now po para pong 35 regulars po at saka may mga J.O. din po kaming bagong pasok po ngayon.

Coun. Hamilton Blanco: 35.

Mrs. Charisma Mojares: So, around mga 50 po siguro, 42.

Coun. Hamilton Blanco: 42, alam po ninyo, sa akin laang ho opinyon ko laang ho ito, sa atin pong mga bisita't sa

aking mga kasamahan, kung meron hong isang pinaka busy na ahensya ang pamahalaang panglunsod wala na hong iba kundi Civil Registrar, City Health. Sabihin na ho natin wag naman hong araw-araw, siguro sa isang linggo may mamamatay at meron ding mabubuhay sabihin ho natin na may magpaparehistro sa inyong ahensya at napaka-busy ho ng inyong opisina.

Mrs. Charisma Mojares: Tama po.

Coun. Hamilton Blanco: Subalit, subalit, take note, napakaliit ho ng opisina ninyo, ang sa akin lang po sana ahm, mapag-aralan po sana ito ng husto na magkaroon ho kayo ng isang mas malawak na opisina dahil kapag po kami'y nadaan diyan para hong isang langgam na sunod-sunod ho ang mga tao na wala naman ho talagang bubong diya't nababasa ho kaawa-awa ho yung mga bata. Ngayon ho sa bawat araw na pumapasok, lumalabas sa inyo't nagpaparehistro, pakasikip pa, sabi nga po eh diyan sa perisuhan natin sa buong Pilipinas ang allowed lamang sa isang detention ay 25 ay nagkakaroon ng 75 na inmate subrang sikip na. Sa inyo ho alam ko yun napakasikip ninyo, tayo naman po ay nagpapagawa rin ng, ang Pamahalaang Lungsod ng Batangas ng mga iba't-ibang building dito sana rin po ma-priority yung oipsina ninyo dahil sa tingin ko ito ho ang kailangang solusyunan natin na para din po sa inyo at para din sa ating mga kababayan, maraming salamat po.

Mrs. Charisma Mojares: If I may sir, sir i-allow po ninyo na in behalf po ng aming tanggapan maraming-maraming pong salamat kasi for the longest timer po ang totoo po ay hinihingi po ng aming tanggapan yun kasi unang-una po ito po ay serbisyo publiko ano po. Una po andun po yung atin pong mga ina na bitbit pa po sa pagpaparehistro so, baka po akala pa ng iba ay may misconception na kailangan pong iharap pa yung bata sa amin para ho irehistro hindi naman po totoo yun eh. Kaya lang syempre isinasabay po nila yun pong unang check-up ng anak po nila sa pagpunta po nila sa amin para po irehistro, kasi madami din po naman ang amin pong tanggap na hindi po galing dito sa atin, hindi po mga taga-rito ano po. Mga galing pong as far as Calamba, Laguna dito pa po nadayo, Quezon at ito po ay ang habol po nila kasi ay mura po yung sa atin pong mga ospital. Kaos po yun pong travel time at saka po yung hirap na bitbit po nila pati po yun pong mga namatayan. So, syempre gusto po namin na ma-accommodate po sila kasi

kahit po yung Senior Citizens natin yun pong facility namin ay talaga pong wala po kasi may second floor po kami pero napakaliit, siguro kung nakita po ninyo, even po yung state records po namin andun po na kami'y binabaha, inu-ulan pero salamat po at naayos po naman yung amin pong bubong ngayon. Pero siguro po kung makikita ninyo ayaw po man namin na katabi namin yung records kasi andun po yung... we have to safeguard them kasi ito po ay mga originals pero wala na po kaming paglayan eh. So, Maraming-marami pong salamat ngayon pa lamang po, kasi talaga pong yan po ay matagal na pong dasal ng amin pong... ng buo pong tanggapan at siguro po'y para din po sa ating mga kliyente kasi kahit po sila ay nalapit po sa amin at nagrereklamo, wala pong facility kami para sa mga mother na nagbe-breastfeed, wala po kaming ganun.

Coun. Hamilton Blanco: Tunay ho yun ma'am kasi nakikita ko po sa pang araw-araw na pakikipagsapalaran nyo dito para kayong siksikang sardinas doon.

Mrs. Charisma Mojares: Opo, kami po ay actually para nga pong hindi na po delineated yung kagaya po nung sa ibang opisina na may kanya-kanya, hindi po, katabi na po namin ang kliyente, kaya po kahit yun pong aming mga gamit ay andun din po yung... talaga pong tinitingnan din namin kasi halo-halo na po kami ang totoo, so salamat po.

Coun. Hamilton Blanco: Thank you din po, Engr. Sonny Godoy good morning po, sir posible po kaya kasi ngayon po July na mamaya we're approaching to the last quarter of this year, posible kaya po na magkaroon po ng isang preparasyon na mapasama po sa annual budget yun pong problema po ng... opo rehabilitation po ng registrar kasi sabi nga po, tunay naman ho talaga yun sobrang siksikan na talaga dun, yun nga pong mga inang nagpapadede ay wala po talagang facility na kung saan ay dapat ho talaga ay meron, napaka-sikip po talaga nila engineer doon.

Engr. Sonny Godoy: Mr. Chairman, with regards po dun sa query ni Konsehal Blanco, ito po ay kasama dun sa ating original na Annual Investment program at kasama po ito dun sa laging pinag-uusapan natin na long term plan n gating City Hall Complex ay maaayos po lahat ng mga facilities mga departamento dito sa atin sa City Hall sa complex na ito. So, ito po'y kinonsider na sa mga pagpa-plano at pag-uusap at pag-uusap dahil nakikita po naman talaga natin yung pangangailangan na isaayos yung kanilang

pangangailangan.

Coun. Hamilton Blanco: Engr. Salamat po dun sa kasagutan ninyo pero sa akin naman po kumbaga po ay trabaho lamang po wag nyo naman pong mamasamain, sana po sir, sana ma-priority po natin ang problemang sinasamana ng Civil registrar kasi araw-araw ho talaga sir may nanganganak, wag namang araw-araw makalwahang araw ilan hong populasyon na meron ang Lungsod ng Batangas milyon na rin po tayo rito, syem pre po may nanganganak dyan araw-araw ay syempre meron din namang namamatay kumbaga eh, kailangan na ho talaga eh, kailangan ng opisina yun na ma-rehabilitate mapalaki at amging maganda poi ka nga ang serbisyo nila kasi alam ko po sa kanila pong katayuan ngayon napakarami pong magre-reklamo diyan sasabihin po nila eh "*kami naman po ay nagbubuwis din kami naman po ay nagbayad din pero yung serbisyong ibinibigay nyo sa amin ay hanggang dito na lamang*", wala naman ho silang magagawa kundi tanggapin na lamang ang sermon na maririnig nila kasi isa silang public servant pero at the end of the day sila nga po'y napagalitan na o nasermunan na wala naman po silang magagawa kundi tanggapin lamang yung trabaho kasi yun po ang obligasyon po nila, marami pong salamat sa inyong kasagutan sana nga lamang po ito'y ma-priority at sana po katuwaan na ho namin na makita ng inyong ahensya na maging lumaki, gumanda, malinis at ang inyo pong serbisyo sa publiko ay maging maayos, maraming salamat po.

Mrs. Charisma Mojares: Salamat po.

Chair: Maraming salamat Councilor Hamilton Blanco, any other ahh, before we proceed to GSD, Office of the City General Services, so rest assured that the augmentation on the Office of the City Registrar shall be included on the Committee Report that will be endorse come our next session.

Mrs. Charisma Mojares: Maraming salamat po sir.

Chair: Sir from our GSD.

Mr. Dante Mercado: Magandang umaga po sa ating Kgg. na Vice mayor at sa ating mga City Councilor, ako po si Dante Mercado from General Services Department and ang purpose po ng pagpunta ko dito'y tungkol sa budget augmentation ng aming office from our repair and

maintenance ng machinery at ng equipment to training expenses which will be use sa amin pong team building and other incidental expenses relative thereto, thank you po.

Chair: Are there any queries, to the augmentation of the Office of the City General Services?

NO ANSWER

So, hearing none we are going to proceed to the Office of the City Budget and sa atin pong representative sa atin pong GSD rest assured that your augmentation shall be included on the Committee Report that will be endorse come our next session, thank you.

Mr. Dante Mercado: Okay po, thank you po.

Chair: Ma'am.

Ms. Marissa Serrano: Thank you, so good morning po sa ating lahat dito naman po sa augmentation ng Office of the City Budget yun pong from sa Personal Services po from salaries and wages Twenty-Two Thousand Five Hundred (22,500) ia-allot po namin sa transportation allowance dahil po nang ang amin pong opisina dati ay may naka-assign na service vehicle ngayon po ay itinurn-over na namin sa GSD dahilang pong ang aming driver na si Marlon ay parang hindi na po nya kayang mag drive, yun naman po ay naka-designate lang hindi talagang driver naka-designate lang as driver so kukulangin po yung aming appropriation para sa aming transportation allowance, tapos po dun sa maintenance and other operating expenses from transportation equipment, repair maintenance to repair, maintenance machinery and equipment. Sa ngayon po ang amin pong copier ay medyo nakikita na po naming may deperensya so malapit na po ang ating budgeting period kakailanganin po namin ang copier so, kailangan po naming ipa-repair yung aming copier po, thank you very much po.

Chair: Ma'am this augmentation is likewise very important so, are there any other queries with regards to the Office of the City Budget sa augmentation?

NO ANSWER

Ms. Leonor Garcia: So hearing none, rest assured ma'am that your augmentation shall be included come our next session. Lastly, our ahh, the augmentation on the Cultural, tourism, historical and other related events

under the Office of the City Mayor, ma'am.

Ms. Leonor Garcia: Good morning po, yun pong sa Cultural Affairs po kaya po kami na deficit sa prizes po ay...

Chair: Ay ma'am can you please state your name just for the record purposes and the division.

Ms. Leonor Garcia: Good morning po ako po si Leonor Garcia representing tourism, regarding po dun sa... na-deficit po kami sir sa prizes dahil po yung street dance and court dance po ay... dati po magkasama yung prizes nila na Fifty Thousand (50,000) Twenty-Five Thousand (25,000) and Fifteen Thousand (15,000) na 3 categories po yun, school division, open division and government po. Ngayon po ang nangyari this year po ay naging... hinati po yung street dance at saka po court dance kaya po yung Two Hundred Seventy Thousand (270,000) ay hindi po namin naisama sa budget po.

Chair: And this is ahh, para po ito sa ating Foundation Day.

Ms. Leonor Garcia: Sublian Festival po.

Chair: Okay, medyo napakalapit na rin ano, so are there any queries with regards to this augmentation from the Cultural and Tourism?

NO ANSWER

So, hearing none rest assured that the augmentation of your division shall be included come our next session and to the other members of our finance committee likewise to our City Administrator if you see any possible impediment with regards to this augmentation please ahhh. Maaari po kayong mag-comment if none then we can adjourn our comitte hearing kung wala naman po tayong nakikita, sa atin pong City Budget, City Treasurer and the City Accountant, do you have any observation with regards to a possible impediment or with regards to the auditing rules and other budgetary procedures, before ma'am, our Administrator Atty. Narcing Macarandang.
