#### ORDINANCE NO. 16 S. 2019

AUTHORIZING THE UTILIZATION OF THE 30% CITY DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (CDRRMC) QUICK RESPONSE FUND AMOUNTING TO FIFTEEN MILLION PESOS (P15,000,000.00) IN COMPLIANCE WITH NDRRMC MEMORANDUM CIRCULAR NO. 01 S. 2019

SPONSOR : COUN. ALYSSA RENEE A. CRUZ COMMITTEE ON APPROPRIATIONS

WHEREAS, as stated in NDRRMC Memorandum Circular No. 01 S. 2019 or "Enjoining all Member Agencies to Support the Nationwide Dengue Epidemic Response", the said agencies are requested to have dengue-awareness campaigns, community participation through Dengue Brigades and assistance in the mobilization of logistics and conduct of chemical interventions;

WHEREAS, it is necessary to utilize a portion of the 30% CDRRMC Quick Response Fund amounting to P15,000,000.00 in order to conduct the said activities which will be beneficial in combating the dengue threat;

NOW THEREFORE, be it ordained by the Sangguniang Panlungsod in session assembled:

- SECTION 1. TITLE. This Ordinance shall be called "Ordinance Authorizing the Utilization of the 30% City Disaster Risk Reduction and Management Council (CDRRMC) Quick Response Fund amounting to Fifteen Million Pesos (P15,000,000.00) in compliance with NDRRMC Memorandum Circular No. 01 S. 2019".
- SECTION 2. COMPLIANCE. Compliance to all auditing rules, regulations and circulars issued by COA and the Department of Finance shall be strictly complied with by the Officials concerned.
- SECTION 3. SEPARABILITY CLAUSE. If for any reason any part of this Ordinance shall be held unconstitutional or invalid other parts thereof which are not affected thereby shall continue to be in full force and effect.
