AUTHORIZING THE REPROGRAMMING OF APPROPRIATIONS OF THE
CITY DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL
UNDER LDRRM TRUST FUND FOR 2019

WHEREAS, Section 336 of the Local Government Code of 1991 states:

SECTION 336. Use of Appropriated Funds and Savings. Funds shall be available exclusively for the specific purpose for which they have been appropriated. No ordinance shall be passed authorizing any transfer of appropriations from one item to another. However, the local chief executive or the presiding officer of the Sanggunian concerned may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations.

NOW THEREFORE, be it ordained by the Sangguniang Panlungsod in Session assembled:

SECTION 1. TITLE. - This Ordinance shall be called "Ordinance Authorizing the Reprogramming of the City Disaster Risk Reduction and Management Council under LDRRM Trust Fund for 2019".

SECTION 2. REPROGRAMMING. The reprogramming of appropriation is hereby approved and authorized to wit:

SECTION 3. LEGAL BASIS. Section 336 of R.A. 7160.

SECTION 6. EFFECTIVITY. This Ordinance shall take effect upon approval of the City Mayor.
