WHEREAS, on 8 March 2020, President Rodrigo Roa Duterte issued Proclamation No. 922 entitled "Declaring A State of Public Health Emergency Throughout the Philippines" because of the local transmission of the Corona Virus Disease (COVID-19) in the Philippines;

WHEREAS, as of date, Batangas City is still under Modified General Community Ouarantine;

WHEREAS, keeping in utmost consideration the ease, health and safety of the constituents, it is deem appropriate to waive the medical clearance fee for individuals securing Health Certificate/Clearance from the City Government;

NOW THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the Sangguniang Panlungsod of Batangas City, in session assembled that;

SECTION 1. TITLE. - This ordinance shall be known and cited as "An Ordinance Waiving the Medical Examination Certificate Fees of Individuals in the Duration of the Community Quarantine in the City Of Batangas.

SECTION 2. COVERAGE. - This ordinance shall apply to all individuals securing Health Certificate/Clearance from the City Health Office, Batangas City Government.

SECTION 3. WAIVER. - The Medical Examination Certificate Fee of One Hundred Pesos (PhP 100.00) provided under Sec. 97, (B),(E) of the Batangas City Revenue Code of 2009 is hereby waived. No fees or any other amount shall be paid by any individual securing Medical Examination Certification Fee or Health Certificate or Health Clearance.

Continuation of Ordinance No. 18 S. 2020

AN ORDINANCE WAIVING THE MEDICAL EXAMINATION CERTIFICATE FEES OF INDIVIDUALS IN THE DURATION OF THE COMMUNITY QUARANTINE IN THE CITY OF BATANGAS

SECTION 4. PERIOD OF WAIVER. – The waiver of fees provided in this Ordinance shall be effective during the period that Batangas City is under any kind of community quarantine only. The lifting of community quarantine shall automatically terminate the effectivity of the waiver.

SECTION 5. REPEALING CLAUSE. – All ordinances, resolutions, rules and regulations, inconsistent with any of the provisions of this ordinance are hereby repealed or modified accordingly.

SECTION 6. SEPARABILITY CLAUSE. – If for any reason any part of this ordinance shall be held unconstitutional or invalid, other parts hereof which are not affected shall continue to be in full force and effect.

SECTION 7. EFFECTIVITY CLAUSE. – This Ordinance shall take effect immediately upon its approval.
