THE LAND BANK OF THE PHILIPPINES IN THE AMOUNT
OF NINETY SEVEN MILLION PESOS (PhP 97,000,000.00)**

WHEREAS, the City Mayor submitted to the Sangguniang Panlungsod for ratification/conformation the Loan Agreement of the Batangas City Government with Land Bank of the Philippines for the amount of Ninety Seven Million Pesos (PhP 97,000,000.00) for the following projects/programs:

Fifty Million Pesos (PhP50,000,000.00)	Improvement of Batangas City Sports Center Oval and other onsite development
Thirty Million Pesos (PhP30,000,000.00)	Land/Site Development of the Proposed Grandstand
Ten Million Pesos (PhP10,000,000.00)	Concreting/rehabilitation of various road projects of the City Government of Batangas
Seven Million Pesos (PhP7,000,000.00)	Concreting/Asphalting/Rehabilitation/ Repair of Barangay Roads

WHEREAS, the Committee on Laws, Rules and Regulations finds the Loan Agreement valid and within the authority of the City Government to enter into and thereby the Committee recommends the ratification/conformation by the Sangguniang Panlungsod of the subject Loan Agreement;

NOW THEREFORE, the Sangguniang Panlungsod in session assembled, hereby promulgates and decrees to ratify/conform the Loan Agreement entered into by the Batangas City Government with the Land Bank of the Philippines in the amount of Ninety Seven Million Pesos (PhP97,000,000.00) for the projects/programs afore-stated.

EFFECTIVITY- This Ordinance shall take effect immediately upon approval of the City Mayor.


