ORDINANCE APPROVING AND RATIFYING THE CONTRACT AGREEMENTS  
DATED DECEMBER 3, 2020 EXECUTED BY AND BETWEEN THE CITY  
GOVERNMENT OF BATANGAS AND VARIOUS CONTRACTORS OF DIFFERENT  
INFRASTRUCTURE PROJECTS IN BATANGAS CITY PRIOR TO THE  
ISSUANCE OF THE NOTICE TO PROCEED

WHEREAS, the City Legal Officer forwarded a letter to the Sangguniang Panlungsod requesting to approve and ratify the Contract Agreements between the City Government and various contractors of the following projects:

1. Improvement of Batangas City Sports Center, Oval and Other On-Site Development
2. Land/Site Development of the Proposed Grandstand
3. Concreting of Road at P. Herrera Street (Additional) *Concreting and Rehabilitation of Road*
4. Concreting/Asphalting/Repair/Rehabilitation of Barangay Road (Poblacion Barangay 1-24) D. Silang Street between M.H. del Pilar Street and Rizal Avenue;

WHEREAS, it is required that the Contract Agreements be approved and ratified by the Sangguniang Panlungsod prior to the issuance of Notice to Proceed.

NOW THEREFORE, the Sangguniang Panlungsod in session assembled, hereby promulgates and decrees to approve and ratify the Contract Agreements dated December 3, 2020 executed by and between the City Mayor Beverley Rose A. Dimacuha and various contractors for the construction of various City projects in the City of Batangas.


EFFECTIVITY. This Ordinance shall take effect immediately upon approval of the City Mayor.



COMMITTEE REPORT

**CONTRACT AGREEMENT OF VARIOUS INFRASTRUCTURE PROJECTS FOR APPROVAL PRIOR TO THE  
ISSUANCE OF THE NOTICE TO PROCEED**

**COMMENTS/RECOMMENDATIONS**

The subject request for the approval of the said contract agreement was referred to the Committee on Laws, Rules and Regulations for its consideration during the Regular Session on December 7, 2020.

The Committee held a hearing on December 9, 2020 and in attendance were the following:

From City Engineer's Office: Engr. Adela B. Hernandez, Mr. Dwight Virgilio C. Arellano and Mr. Jose Gallardo T. Palas; from Vicmar Contractor Inc.: Mr. Eugene Moreno; from Berto Lucci: Mr. Honorio Loyola and Mr. Paolo Angelo Loyola. Also present are the Chairperson Coun. Alyssa Renee A. Cruz and committee members Coun. Gerardo A. Dela Roca, Coun. Julian Villena and Coun. Nelson J. Chavez. The Vice Mayor Emilio Francisco Berberabe Jr. and other members of the Sangguniang Panlungsod Councilors Nestor Dimacuha, Michael Thomas Pastor, Maria Aleth Lazarte, Lorenzo A. Gamboa Jr., and SK Federation President Marjorie Manalo, were also present.

During the committee hearing, members of the Sangguniang Panlungsod acknowledged the presence of contractors of various projects to be approved and ratified since it is crucial for the City Government to know every details and status of the said projects. The City Engineer presented the scope and background of various projects including some technical descriptions of the same. After the presentation, member of the Sangguniang Panlungsod advised the City Engineer to furnish the body copy of submittals related to the projects including its background, scope and methodology.

With the view that this request will eventually be favorable to the City of Batangas and its inhabitants, the Sangguniang Panlungsod perceives the essentiality to undertake necessary infrastructure and development projects that will play a vital role in the promotion of the general welfare on all sectors essential to economy, safety and security.

Finding no legal, budgetary and auditing impediment with regards to the subject matter, the Committee hereby recommends:

1. The adoption of this Committee Report
2. The approval of an Ordinance hereto attached exempting it from the Three-Reading Rule, subject to the condition that all the required documents are submitted to the Committee such as:
  - a. Engineering drawings (plans and details)
  - b. Bill of Quantity (BOQ) and specification
  - c. Bar chart/ Program (Project) Management and Review Technique (PERT) or Critical Path Method (CPM)
  - d. Environmental Health and Safety (EHS) program and performance standard plan (R.A. 11058)
  - e. Waste Management Program (R.A. 9003)
  - f. Occupational Health Program including health screening and contact tracing (R.A. 11058)
  - g. COVID-19 Response and Management
  - h. Job Hazard Analysis
  - i. Methodology of Work

and that the above mentioned documents be made an integral part of the Ordinance.
