ORDINANCE NO. 7 S.2020

AN ORDINANCE APPROPRIATING THE AMOUNT OF TWO HUNDRED FORTY-FOUR MILLION, THREE HUNDRED TWENTY THREE THOUSAND, SEVEN HUNDRED THIRTY FOUR PESOS AND SEVENTEEN (17/100) CENTAVOS (P 244, 323, 734.17) FOR THE SUPPLEMENTAL BUDGET NO. 1 OF THE CITY GOVERNMENT OF BATANGAS FOR CALENDAR YEAR 2020

WHEREAS, on April 17, 2020, the Honorable City Mayor Beverley Rose A. Dimacuha submitted to the Sangguniang Panlungsod the Supplemental Budget No. 1 of the City Government of Batangas for Calendar Year 2020 amounting to P244,323,734.17 for approval and authorization;

WHEREAS, the funding sources for the Supplemental Budget No. 1 of the City Government comes from the Bayanihan Grant to Cities and Municipalities representing the one month Internal Revenue Allotment of Batangas City in the amount of P93,633,449.00, Surplus of the 20% Development Fund in the amount of P100,690,285.17 and Savings of Continuing Appropriation in the amount of P50, 000,000.00;

WHEREAS, the passage of this Appropriation Ordinance has been certified urgent by the city mayor last April 17, 2020;

WHEREAS, an examination and analysis of the documentary requirements, the program of appropriations, the objects of expenditure show no legal impediment for the approval of the Supplemental Budget No.1 of the City Government of Batangas.

BE IT ORDAINED BY THE SANGGUNIANG PANLUNGSOD OF BATANGAS CITY THAT:

SECTION 1. TITLE – This Ordinance shall be known and cited as the “**Supplemental Budget No. 1 of the City Government of Batangas City for Calendar Year 2020**”

SECTION 2. APPROPRIATION OF FUNDS – There is hereby appropriated the amount of **two hundred forty-four million, three hundred twenty three thousand, seven hundred thirty four pesos and seventeen (17/100) centavos (p 244, 323, 734.17)** from the Bayanihan Grant to Cities and Municipalities representing the one month Internal Revenue Allotment of Batangas City in the amount of P93,633,449.00, Surplus of the 20% Development Fund in the amount of P100,690,285.17 and Savings of Continuing Appropriation in the amount of P50, 000,000.00 which are certified by the OIC-City Treasurer and City Accountant as enumerated in the Statement of Funding Sources (LBP Form No.8), and which are available for Supplemental Appropriation in accordance with the Objects of Expenditure as enumerated in the statement of Supplemental Appropriation for CY 2020(LBP Form No.9).

SECTION 3. COMPLIANCE

3.1 Any change in the budget shall be in accordance with the provision of Section 321 of the Local Government Code of 1991.

3.2 Disbursement and expenditures shall comply with the budgetary requirements and limitations provided in Section 324 and Section 325 of R.A. 7160 and all accounting and auditing rules and regulations.

3.3 Compliance to DILG memorandum Circular No.2011 – 134 dated September 19, 2011 on full disclosure of local budget and finance, bids and public offerings.

3.4 Compliance to Sections 22, 26 and 27 of R.A. 7160 required.

SECTION 4. REPEALING CLAUSE – All ordinances, rules and regulations, orders of parts thereof which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 5. SEPARABILITY CLAUSE – If for any reason any part of this ordinance shall be held unconstitutional or invalid, other parts hereof which are not affected shall continue to be in full force and effects.


SECTION 6. EFFECTIVITY – This Ordinance shall take effect upon approval of the City Mayor.




