#### ORDINANCE NO. 2 S. 2021

AN ORDINANCE AMENDING ORDINANCE NO. 30 S. 2019 OTHERWISE KNOWN AS "AN ORDINANCE ON COLLECTION OF CORRESPONDING BARANGAY CLEARANCE FEE IN THE APPLICATION FOR ANY BUSINESS RELATED TRANSACTIONS, AS AMENDED"

BE IT ORDAINED by the Sangguniang Panlungsod of Batangas City that:

SECTION 1. Section 4 of Ordinance No. 30 S. 2019, as amended, is hereby further amended to read as follows:

"Section 4. Authority to collect Barangay Clearance Fee of Business Related Transactions and Construction-Related Permits. - The City of Batangas is given the authority to collect Barangay Clearance Fee of Business Related Transactions and Construction-Related Permits subject to the remittance to the subject Barangay.

**SECTION 2**. This Ordinance shall take effect immediately after the approval of the Honorable City Mayor.

#### ORDINANCE NO. 30 S. 2019

AN ORDINANCE ON COLLECTION OF CORRESPONDING BARANGAY CLEARANCE FEE IN THE APPLICATION FOR ANY BUSINESS RELATED TRANSACTIONS

SPONSOR : COUN. ALYSSA RENEE A. CRUZ

WHEREAS, there is a need to streamline/simplify the process of business registration in the City of Batangas to provide a more efficient and effective revenue collection and to promote a friendlier atmosphere for taxpayers and investors;

WHEREAS, when regulations are simple and transparent entrepreneurs need not to suffer from red tape and time consuming transactions;

whereas, the EODB Act of 2018 or Republic Act 11032, otherwise known as "An Act Promoting Ease of Doing Business and Efficient Delivery of Government Services", as signed into law seeks to make the process of putting up and running a business in the Philippines easier and more efficient;

WHEREAS, Section 11 (f) of RA 11032 provides that Barangay clearances and permits related to doing business shall be applied, issued and collected at the City in accordance with the prescribed processing time of said Act Provided, that the share in the collection shall be remitted to respective Barangays; and

WHEREAS, Barangays in the City of Batangas, enacted Barangay Ordinances to authorize the City of Batangas to issue barangay clearance and collect corresponding barangay clearance fee in the application for any business related transactions subject to the remittance of the aforesaid fees to the barangay and conditions hereunder;

NOW THEREFORE, be it ordained as it is hereby ORDAINED by the Sangguniang Panlungsod of Batangas City in session duly assembled the following:

SECTION 1. Title. This ordinance shall be known as the "Batangas City Ordinance in Collection of Corresponding Barangay Clearance Fee".

AN ORDINANCE ON COLLECTION OF CORRESPONDING BARANGAY CLEARANCE FEE IN THE APPLICATION FOR ANY BUSINESS RELATED TRANSACTIONS

SECTION 2. Coverage. This policy applies only to the issuance of Barangay Clearance for business permit and locational clearance (as a requirement for the issuance of building permit) at the City. Other clearances for other purposes shall still be obtained at the Barangay.

SECTION 3. Definition of Terms. The words and phrases used in this ordinance are hereby defined as follows:

Barangay Clearance - refers to any and all documents issued by the barangays with or without corresponding fees as defined in their ordinances relative to or in relation to the issuance of business permit and locational/zoning clearance by the city or any other permit as may be required. (IRR OF RA 11032)

Barangay Clearance Fees - is an amount imposed by the barangays through an ordinance and collected by the city in relation to the issuance of business permit 'and locational/zoning clearance by the city/municipality.

Business Permit - is a document that must be secured from the city government usually through its Business Permits and Licensing Office (BPLO), for a business to legally operate in the locality, (IRR of RA 11032).

Locational Clearance - is a clearance issued by the Zoning Administrator/Zoning Officer to a project that is allowed under the provisions of an ordinance of a particular City. It is a requirement for the issuance of Building Permit. (House and Land Use Regulatory Board - Comprehensive Land Use Plan Guidebook).

SECTION 4. Authority to collect Barangay Clearance Fee of Business Related Transactions - The City of Batangas is given the authority to collect Barangay Clearance Fee subject to the remittance to the subject Barangay.

AN ORDINANCE ON COLLECTION OF CORRESPONDING BARANGAY CLEARANCE FEE IN THE APPLICATION FOR ANY BUSINESS RELATED TRANSACTIONS

SECTION 5. Rate of Barangay Clearance Fee to be Collected - The rate of Barangay Clearance Fee to be collected by the City for the issuance of clearance shall be computed in accordance with the subject Barangay Revenue Ordinance herein attached as "Annex A", and made as an integral part hereof.

SECTION 6. Barangay Clearance Signatory - Electronic Signature of Punong Barangay shall appear in all barangay clearance issued.

SECTION 7. Reporting and Remittance - The City shall remit the Barangay Clearance Fee collected to the subject Barangay not later than seven (7) working days of the ensuing month with the list of the issued Building and Business Permit.

SECTION 8. Separability Clause - If for any reason, a part of this Ordinance is declared illegal or invalid, other parts or provisions hereof which are not affected thereby shall remain valid and in full and effect.

SECTION 9. Repealing Clause - All previous Ordinance and rules/regulations which are inconsistent with the provisions of this Ordinance are hereby deemed, modified or repealed accordingly.

SECTION 10. Effectivity Clause - This Ordinance shall take effect upon approval of the City Mayor.

4. Proposed Ordinance entitled: "An Ordinance Amending Ordinance No. 30 S. 2019 Otherwise Known As "An Ordinance on Collection of Corresponding Barangay Clearance Fee in the Application for any Business Related Transactions, as Amended".

#### Sinabi ni Konsehal Nestor Dimacuha:

"I would just like to inform the one hundred five barangays which is a composition of Batangas City that this is not the Sangguniang Panlungsod who burden or prohibit them of issuing clearances, the Republic Act 11032 automatically amend Section 152 of the Local Government Code which is the issuance of clearances by the barangay, meron pa rin ho kayong authority, there is still authority na you can issue barangay clearance for other purposes like sa mga working requirements kayo pa rin,

however, pwede kayong mag-generate ng income don sa ibinibigay na authority ng Sanggunian kung meron kayong tax ordinance, dahil kung wala kayong tax ordinance, walang mare-remit sa inyo, na dapat maging malinaw po kayo, i-exercise ninyo ang inyong taxing power under Section 152 of the Local Government Code, enact an ordinance that would ... na magkakaroon kayo ng power na matanggap itong mga remittance na ito ano po, dahil may mga ilan pong barangay officials ay hindi ho nauunawaan at ang sinasabi ay tinanggalan na raw namin ng power na mag-issue ang mga barangay official, NO, there is a law that automatically amends Section 152 of the Local Government Code, however, further there is another law which was signed during December 23 which suspends the issuance of permits, clearances, certificates both from national, local government, which is otherwise known as the Republic Act 115171, the Acceleration and Streamlining of Government Project During Emergency Crisis, so ito pong batas na ito ang maaaring maging isang problema once inimplement ang batas, dahil yong batas na yan, the R.A. 115171 authorize the President, ang president na po ang binigyan ng authority ng batas na ito, so ibig sabihin kahit barangay clearance, the permits, national level or local government, pag sinabi ng presidente ini-invoke po yong R.A. 115171 wala na tayong habol rito pare-pareho ano po, dapat maging malinaw yan at dapat makagawa tayo ng measure na hindi naman natin kina-counter yon, dapat measure that would protect and put safeguard in our authority na meron din tayong dapat i-exercise, meron din tayong Local Government Code, it is not only the 11032 na dapat ay maimplement however, sana hindi ma-undermine yong authority ng barangay ng LGU, or any LGUs, barangay man o City Government".
