#### ORDINANCE NO. 3 S. 2021

AN ORDINANCE EXTENDING THE DEADLINE OF THE RENEWAL OF BUSINESS PERMITS UNTIL FEBRUARY 15, 2021 WITHOUT INCURRING ANY INTEREST, PENALTY OR SURCHARGES FOR THE YEAR 2021

WHEREAS, the COVID-19 pandemic has greatly affected nations worldwide, including the Philippines and has caused and is continuing to cause loss of lives and disruption to the economy. The imminent threat to everyone's safety led to the restructuring of approaches to overcome these challenges or to adapt or transition to the "new normal";

**WHEREAS**, the City of Batangas, among others, had been greatly affected by COVID-19 and is still placed under General Community Quarantine (GCQ) up to present. More than 11,000 taxpayers in the City of Batangas are affected by this health crisis;

WHEREAS, Ordinance No. 19 S. 2008, as amended, otherwise known as "AN ORDINANCE ADOPTING THE BATANGAS CITY REVENUE CODE OF 2009", specifically Section 9 thereof, prescribes the time of payment of all local taxes, fees, or charges which shall be paid within the month of January or on the first month of the subsequent year, as the case may be;

**WHEREAS**, the Sanggunian may, for justifiable reason or cause, extend the time of payment of such taxes, fees or charges without surcharges or penalties, but only for a period not exceeding six (6) months;

WHEREAS, as the country is still in continuous battle against the threat of the COVID-19 pandemic and the health and safety protocols are still observed, it is necessary, beneficial, and practical to have an extension of deadline for the payment of the business permits, local taxes, fees and charges without incurring any interest, penalty or surcharges for the current year 2021;

**NOW THEREFORE**, be it **ORDAINED** as it is hereby **ORDAINED** by the Sangguniang Panlungsod of Batangas City in a session duly assembled the following:

### Continuation of Ordinance No. 3 S. 2021

## AN ORDINANCE EXTENDING THE DEADLINE OF THE RENEWAL OF BUSINESS PERMITS UNTIL FEBRUARY 15, 2021 WITHOUT INCURRING ANY INTEREST, PENALTY OR SURCHARGES FOR THE YEAR 2021

**SECTION 1. Coverage.** This Ordinance applies only to the extension of deadline of the payment of all local taxes, business permits, fees and charges payable to the City Government of Batangas for the year 2021.

**SECTION 2**. Time for payment. - All local taxes, fees or charges for the year 2021 shall be payable up to February 15, 2021.

**SECTION 3. Applicability** – The provisions of this Ordinance as regards the extension for the payment of all taxes, business permits, fees and charges shall be applicable for taxable year 2021 only. The deadline of payment provided under the Revenue Code of Batangas City which is within the month of January or on the first month of the subsequent year shall be in effect in the taxable years thereafter.

SECTION 4. Separability Clause – If for any reason, a part if this Ordinance is declared illegal or invalid other parts or provisions hereof which are not affected thereby shall remain valid in full force and effect.

SECTION 5. Repealing Clause – All previous Ordinances and rules/regulations which are inconsistent with the provisions of this Ordinance are hereby deemed, modified or repealed accordingly.

SECTION 6. Effectivity Clause – This Ordinance shall take effect immediately upon approval.
