**ORDINANCE NO. 8 S. 2021**

**AN ORDINANCE GRANTING FIFTY PERCENT (50%) DISCOUNT ON THE MARKET RENTAL FEES OF STALL HOLDERS ENGAGED IN THE BUSINESS OF SELLING NON-ESSENTIAL PRODUCTS IN THE PUBLIC MARKET OF BATANGAS CITY FROM APRIL 2021 TO JUNE 2021**

**WHEREAS**, while we are still under the diverse effects of the current COVID-19 pandemic, the economic activities of the market stalls in the Public Markets of Batangas City were not fully restored and still flagging in a normal downturn;

**WHEREAS**, the City Government of Batangas recognizes the significant and dramatic effects of these guidelines and is continuously crafting measures to alleviate the consequences of the COVID-19 outbreak especially to its market stall lessees in the Public Market of Batangas;

**NOW THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED**, by the Sangguniang Panlungsod of Batangas City, in session assembled that:

**SECTION 1. TITLE.** – This ordinance shall be known and cited as “An Ordinance Granting Fifty Percent (50%) discount on the Market Rental Fees of Stall Holders Engaged in the Business of Selling Non-Essential Products in the Public Market of Batangas City from April 2021 to June 2021”.

**SECTION 2. COVERAGE.** – This ordinance shall apply to all duly registered market stall holders in the Batangas City Public Market 1, 2, and 3 that is engaged in selling non-essential products.

**SECTION 3. DEFINITION OF TERMS.** – Whenever used in this ordinance, the terms shall be construed to have the following meaning:

- a. **Public Market** - refers to the place, building or structure designated as such by the Sangguniang Panlungsod. It includes Market 1, 2, and 3 of the Batangas City Public Market.
- b. **Non-Essential Products** - refer to non-food products sold in the city market such as but not limited to party needs, souvenirs, toys, clothing, glassware, native products and shoes.
- c. **Market Rental Fees** - refer to the fees imposed to lessees of stalls in the city market as per Section 109 of the Batangas City Revenue Code of 2009.
- d. **Stall Holder** - refers to the awardee or recipient of the award for a particular space located in the city market.

**SECTION 4. – RENTAL FEES FOR STALLS OF NON-ESSENTIAL PRODUCTS.**

– The stall holders engaged in the business of selling non-essential products are entitled to fifty percent (50%) discount on market rental fees, whether these stalls continued their operation or not from April to June 2021 provided further that the said market fee rentals shall be made quarterly by those stall holders for assessment by the City Government, upon the recommendation of the City Market Administrator.


**SECTION 5. IMPLEMENTING RULES AND REGULATIONS.** – The City Mayor, upon the recommendation of the City Market Administrator, shall issue the implementing rules and regulations as may be necessary.

**SECTION 6. SEPARABILITY CLAUSE.** – In case any provision of this ordinance is declared to be void or unconstitutional, other provisions not affected by the declaration of invalidity or unconstitutionality shall remain in force.

**SECTION 7. REPEALING CLAUSE.** – All existing ordinances, resolutions, rules and regulations, inconsistent with any of the provisions of this ordinance are hereby repealed, amended or modified accordingly.

**SECTION 8. EFFECTIVITY CLAUSE.** – This ordinance shall take effect immediately upon its approval.
