ORDINANCE NO. 6 S. 2022

AN ORDINANCE PRESCRIBING THE AMOUNTS OF REGISTRATION FEE AND
OTHER CHARGES FOR THE IMPLEMENTATION OF RA 11222 OTHERWISE
KNOWN AS THE SIMULATED BIRTH RECTIFICATION LAW

WHEREAS, the General Welfare Clause of the Local Government Code of 1991 authorizes the enactment of ordinances which shall enhance, improve public morals, maintain peace and order and preserve the comfort and convenience of the inhabitants;

WHEREAS, Republic Act No. 11222, also known as "An Act Allowing the Rectification of Simulated Birth Records and Prescribing Administrative Adoption Proceedings for the Purpose", grants amnesty and provides legitimate means to rectify simulated birth records, fix the status and filiation of a child whose birth was simulated, exempt from criminal, civil, and administrative liability those who caused the simulation of the child's birth, and provide a simpler and less costly administrative adoption proceeding;

WHEREAS, the City Government is authorized under RA 11222 to prescribe appropriate registration fees and other administrative charges for its effective implementation;

NOW THEREFORE, BE IT ENACTED by the Sangguniang Panlungsod in session assembled:

SECTION 1. PURPOSE. - This Ordinance provides for the registration and other administrative fees to be charged by the Office of the City Civil Registrar for the rectification of simulated birth records and administrative adoption proceedings, in accordance with the provisions of RA 11222 otherwise known as "An Act Allowing the Rectification of Simulated Birth Records and Prescribing Administrative Adoption Proceedings for the Purpose".

SECTION 2. FEES. - It is hereby prescribed the following fees and charges for the purpose of rectification of simulated birth records and administrative adoption proceeding with the Office of the City Civil Registrar of Batangas City:

SECTION 3. COLLECTION OF FEES. - All fees and charges proceeding from the implementation of this Ordinance shall be collected by the City Treasurer or his duly authorized representative and shall accrue to the General Fund of the City Government.

SECTION 4. SEPARABILITY CLAUSE. - If for any reason or reasons, any part of this ordinance shall be held unconstitutional or invalid other parts hereof which are not affected thereby shall continue to be in full force and effect.

SECTION 5. REPEALING CLAUSE. - All provisions of ordinances, executive orders, or resolutions inconsistent herewith are hereby repealed and/or modified accordingly.

SECTION 6. EFFECTIVITY. - This Ordinance shall take effect after approval by the City Mayor and completion of publication in a newspaper of general circulation in the Cities and Province of Batangas.
