ORDINANCE AMENDING SECTIONS 108 AND 109 ARTICLE XVII OF ORDINANCE NO. 23 S. 2019, OTHERWISE KNOWN AS THE BATANGAS CITY TRAFFIC ORDINANCE OF 2020

**WHEREAS**, Section 186 of R.A. No. 7160, otherwise known as the Local Government Code provides that local government units may exercise the power to levy taxes, fees or charges, provided, that the taxes, fees, or charges shall not be unjust, excessive, oppressive, confiscatory or contrary to declared national policy;

**WHEREAS**, Ordinance No. 23 S. 2019 has provided for areas in the City of Batangas which can be used as Pay Parking Zones and the amount of fees to be collected from the list of motor vehicles that park therein;

**WHEREAS**, such amount of parking fees are reasonable regulatory fees commensurate with the cost of the services being provided to the end users;

**WHEREAS**, to broaden the purpose and reach of the law, cover streets actually used as pay parking areas particularly around the Old and New Markets of the City of Batangas and to impose fair equitable fees among motorists, there is a need to exact parking fees from motorcycles, tricycles and electronic bicycles and tricycles which use the Pay Parking Zones;

**WHEREAS**, other areas and streets particularly around the Old and New Markets of the City of Batangas are actually used as Pay Parking Zones but are not yet included in Ordinance No. 23 Series of 2019.

**NOW THEREFORE**, be it **ORDAINED** as it is hereby **ORDAINED** by the Sangguniang Panlungsod of Batangas City, in a Regular Session duly assembled the following:

**SECTION I.** Section 108 of Ordinance No. 23 S. 2019 or the **BATANGAS CITY TRAFFIC ORDINANCE OF 2020** is hereby amended as follows:

“Section 108 - Ordinance No. 3, Series of 2003 is hereby adapted.  
Pay Parking Zone - Private vehicles and delivery vehicles shall be allowed to park along the streets hereunder enumerated from 6:00 A.M. to 6:00 P.M.

- a. D. Silang St.
  - 1. East Lane, from M.H. del Pilar towards Rizal Ave.
- b. P. Dandan St.
  - 1. West Lane, from P. Panganiban St. to M.H. Del Pilar St.
- c. P. Burgos St.
  - 1. East Lane, from P. Panganiban St. to M.H. Del Pilar St.
- d. Don Julian Pastor Memorial Market (DJPM) Site (New Market)
  - 1. Within the periphery of the market.
- e. Batangas City First Public Market (BCFPM) Site (Old Market)
  - 1. Within the periphery of the market:
    - a. East Lane of D. Silang St.
    - b. South Lane of V. Luna St. from D. Silang to P. Genato St.
    - c. South Lane and North Lane of Evangelista St., from P. Genato St. to D. Silang St.

Section 109 - Unless otherwise provided by law or ordinance, the parking fee payable by the driver or operator of the vehicle using the street mentioned in the preceding Section for the first two (2) hours or less shall be as follows:

- a. Motorcycles with or without Sidecars / Electric Bicycles or Electric Tricycles - Php 10.00

- b. Private Cars / Jeepneys - Php 20.00
- c. Delivery Vans / Jeepneys - Php 40.00
- d. Cargo / Delivery Trucks - Php 60.00

Provided, that delivery or private courier riders / drivers who will utilize the Pay Parking Zones to deliver or pick up parcels for delivery elsewhere shall be exempt from the parking fees stated herein, provided further, that such delivery or pick up shall not exceed fifteen (15) minutes, otherwise the parking fees shall apply to them.

**SECTION II. EFFECTIVITY.** This Ordinance shall take effect upon approval by the City Mayor and publication in a news paper of general circulation in the Province and Cities of Batangas.

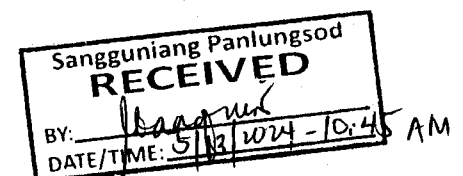

Gentlemen and Mesdames,

Referred to the Committee on Transportation and Committee on Laws, Rules and Regulations, is the aforementioned subject. Committee Hearing was held on April 11, 2024, at 10:00 in the morning at the Sangguniang Panlungsod Session Hall. Present during the Committee Hearing are the Committee Chairman on Transportation Hon. Nelson J. Chavez and Committee Chairman on Laws, Rules and Regulation Hon. Nestor "Boy" E. Dimacuha, Hon. Vice Mayor and Presiding Officer Atty. Alyssa Renee A. Cruz and Sangguniang Panlungsod Members. Invited guests who attended the hearing are Atty. Mel Gainza – City Legal Office and Mr. Chris Mark Banaag of TDRO.

During the said hearing, the proposed amendment of Article XVII, Section 108 and 109 of Ordinance No. 23 S. 2019, Otherwise Known as the "Batangas City Traffic Ordinance of 2020" was formally enrolled to the Sangguniang Panlungsod for scrutiny, and thorough study, it was learned that the primary purposed was to cover streets actually used as pay parking areas identified in Old Market and New Market of Batangas City and to impose fair equitable fees among motorist, further it was imperative to exact parking fees from motorcycles, tricycles and electronic bicycles and tricycles who will utilized the pay parking zones.

The fee imposed will be in a form of regulatory fees to simply put the primary purpose is to support the traffic development of the city government.
