**ORDINANCE NO. 22-005 S. 2025**

**AN ORDINANCE GRANTING HONORARIUM TO THE SANGGUNIANG KABATAAN OFFICIALS IN THE CITY OF BATANGAS PURSUANT TO REPUBLIC ACT NO. 11768**

**SPONSOR** : **SP MEMBER MARCUS MANUEL D. CASTILLO**  
 Chairman, Committee on Youth and Sports Development

**WHEREAS**, Republic Act (R.A.) No. 10742, as amended by Republic Act No. 11768, institutionalized additional reforms to revitalize youth participation in local governance by providing honorarium, other benefits, and privileges to Sangguniang Kabataan (SK) Members, including the SK Treasurer and Secretary;

**WHEREAS**, Section 16 of the same law provides that "The local government units may provide additional honorarium as well as social welfare contributions and hazard pay to the Sangguniang Kabataan chairperson and the elected and appointed members through their own local ordinances: Provided, That the honorarium as stated in this section shall be subject to the post-audit jurisdiction of the COA";

**WHEREAS**, the Department of Budget and Management (DBM) has issued Local Budget Circular (LBC) No. 148, dated 23 December 2022, to lay down the implementing guidelines on the grant of honorarium to SK Officials pursuant to R.A. No. 11768;

**WHEREAS**, the City Government of Batangas acknowledges the significant role of the SK officials in promoting and initiating programs for the general welfare, development, and empowerment of youth, formulating the Comprehensive Barangay Youth Development Plan, and partnering with the Local Youth Development Council in planning and executing projects and programs of specific advocacies such as good governance, climate change adaptation, disaster risk reduction and resiliency, youth employment and livelihood, health and anti-drug abuse, gender sensitivity, and sports development, among its myriad responsibilities;

**WHEREAS**, in recognition of their invaluable and incomparable participation in local governance, the City Government of Batangas seeks to grant a monthly honorarium to all SK elected and appointed members, in the amount of FIVE HUNDRED PESOS (Php 500.00) for each SK Official;

**NOW, THEREFORE**, the Sangguniang Panlungsod in session duly assembled, ordains and decrees:

**SECTION 1. TITLE.** - This Ordinance shall be known and cited as "**AN ORDINANCE GRANTING HONORARIUM TO SANGGUNIANG KABATAAN OFFICIALS IN THE CITY OF BATANGAS PURSUANT TO REPUBLIC ACT NO. 11768.**"

**SECTION 2. PURPOSE.** - The purpose of this ordinance is to grant honorarium to all SK Chairpersons, SK Members, Treasurer, and Secretary (*collectively referred to as "SK Officials"*) in recognition of their essential roles and contributions to local governance and youth development.

**AN ORDINANCE GRANTING HONORARIUM TO THE SANGGUNIANG KABATAAN OFFICIALS IN THE CITY OF BATANGAS PURSUANT TO REPUBLIC ACT NO. 11768**

**SECTION 3. PAYMENT.** - The City Government of Batangas hereby grants an honorarium, through a monthly allowance of **FIVE HUNDRED PESOS (Php 500.00)** to each SK Official, in accordance with Item 3.4 of the Handbook on the Financial Transactions of the Sangguniang Kabataan issued through COA Circular No. 2020-003 dated 28 January 2020.

**SECTION 4. GUIDELINES.** - The Honorarium shall be granted in accordance with the guidelines, under DBM LBC No. 148, dated 23 December 2022:

- 4.1 The grant of the additional honorarium shall be subject to the request of SK Officials, through a letter by the SK Chairperson, submitted to the City Government;
- 4.2 The release of the honorarium shall be contingent on the attendance of the SK Officials in the monthly meeting of the SK in their respective barangay, as evidenced by the attendance sheet, and/or minutes of the SK meeting;
- 4.3 In no case shall the grant of additional honorarium to SK Officials result in a situation where the total honoraria to be received by the SK Officials will be more than the amount of honorarium being received by the barangay officials of the mother barangay of the SK. In the case of the SK Chairperson, the total honorarium to be received shall not be more than the amount of honorarium being received by the members of the Sangguniang Barangay; and
- 4.4 The grant of additional honorarium to be received by the SK Chairperson and the elected and appointed members shall not result in the total honorarium exceeding the rate equivalent to SG 9, Step 1 in the salary schedule implemented by the City Government.

**SECTION 5. REPORTING.** - The grant of honorarium shall be subject to the pertinent budgeting, accounting, and auditing laws, rules, and regulations, including but not limited to the following:

- 5.1 The grant of additional honorarium to the SK Officials shall be taken up as a financial subsidy to SK in the book of accounts of the City Government;
- 5.2 The honorarium shall be included in the Annual Investment Program of the City Government;
- 5.3 The honorarium shall be accounted for and recorded in the Registry of Specific Purpose Fund Commitments, Payments, and Balances of the SK concerned; and
- 5.4 The honorarium shall be transferred or downloaded to the account of the SK on a quarterly basis.

**SECTION 6. MONITORING AND EVALUATION.** - The Local Youth Development Office (LYDO) shall be responsible for the monitoring and evaluation of the grant of honorarium charged against the SK funds pursuant to DILG Memorandum Circular No. 2020-138 dated 15 October 2020.

The Internal Audit Service (IAS) shall be responsible for the monitoring and evaluation of the grant of additional honorarium charged against the funds of the City Government, to the SKs.

**SECTION 7. SOURCE OF FUNDS.** - The funding for the additional allowance shall be sourced from the City Government's annual budget and/or supplemental budget, subject to applicable budgeting, accounting, and auditing rules and regulations.

**SECTION 8. POST-AUDIT.** - The grant of the allowance shall be subject to the post-audit jurisdiction of the Commission on Audit (COA) to ensure compliance with existing laws and regulations.

**SECTION 9. REPEALING CLAUSE.** - All ordinances, rules, and regulations, orders or parts thereof, which are inconsistent with the provisions of this ordinance are hereby repealed or modified accordingly.

**SECTION 10. SEPARABILITY CLAUSE.** - If any provision of this ordinance is declared unconstitutional or invalid, the remaining provisions shall not be affected and shall remain in full force and effect.

**SECTION 11. EFFECTIVITY CLAUSE.** - This ordinance shall take effect immediately upon its approval and publication in accordance with applicable laws.

**JOINT COMMITTEES ON YOUTH AND SPORTS DEVELOPMENT, AND APPROPRIATIONS**

**FINDINGS:**

The Joint Committees on Youth and Sports Development, and Appropriations briefly made an overview of the subject and hereby find the following:

1. The Sangguniang Panlungsod members and members of the Joint Committees mentioned that the City Government of Batangas acknowledges the role of the SK officials in different programs and activities of the City.
2. The significance of the Ordinance is for the City Government of Batangas to be sure that there will be no legal impediments and to be in compliance with the provisions of Republic Act No. 11768.
3. As mentioned by LYDO Officer, Mr. Nelberth D. Magbanua, SK Officials, including the SK Secretary and SK Treasurer, shall adhere to the Implementing Rules and Regulations (IRR) of their respective SK Councils.
4. City Budget Officer, Mr. Manolo M. Perlada, stated that the funds needed in this additional incentive for the SK Officials is included in the Annual Investment Plan and Annual Budget for Calendar Year 2025.
5. The City Legal Office revised the Ordinance with the comments and suggestions of the Sangguniang Panlungsod members and the members of the Joint Committees.

**RECOMMENDATIONS:**

Considering that the joint committees find no legal impediments, the same hereby recommend:


1. The adoption of this Committee Report; and
2. Approval of the attached Ordinance on its second and final reading.
