ORDINANCE NO. 25-037 S. 2025

AN ORDINANCE APPROVING THE APPROPRIATION AMOUNTING TO FIVE HUNDRED FIFTY-SIX MILLION SIX HUNDRED FORTY-FOUR THOUSAND TWO HUNDRED NINETY-NINE PESOS AND SEVENTY-NINE CENTAVOS (PHP 556,644,299.79) FOR THE SUPPLEMENTAL BUDGET NO. 3 OF THE CITY GOVERNMENT OF BATANGAS FOR CALENDAR YEAR 2025

WHEREAS, the Supplemental Budget No. 3 of the City Government of Batangas for Calendar Year 2025 amounting to **Five Hundred Fifty-Six Million Six Hundred Forty-Four Thousand Two Hundred Ninety-Nine Pesos and Seventy-Nine Centavos (Php 556,644,299.79)** is for approval and authorization;

WHEREAS, the funding sources for the Supplemental Budget No. 3 of the City Government of Batangas for Calendar Year 2025 comes from New Revenue Sources – Share from National Wealth DOE ER-1-94 2025 amounting to Php 49,874,577.60; Actual Collection in Excess of the Estimated Income amounting Php 220,179,846.15; and Savings amounting Php 286,589,876.04 with total available for supplemental appropriation amounting to Php 556,644,299.79, as certified by the City Accountant and the City Treasurer.

BE IT ORDAINED BY THE SANGGUNIANG PANLUNGSOD OF BATANGAS CITY THAT:

SECTION 1. TITLE. - This Ordinance shall be known and cited as the "Supplemental Budget No. 3 of the City Government of Batangas for Calendar Year 2025."

SECTION 2. APPROPRIATION OF FUNDS. - There is hereby appropriated the total amount of Five Hundred Fifty-Six Million Six Hundred Forty-Four Thousand Two Hundred Ninety-Nine Pesos and Seventy-Nine Centavos (Php 556,644,299.79) from New Revenue Sources – Share from National Wealth DOE ER-1-94 2025 amounting to Php 49,874,577.60; Actual Collection in Excess of the Estimated Income amounting Php 220,179,846.15; and Savings amounting Php 286,589,876.04 with total available for supplemental appropriation amounting to Php 556,644,299.79, as certified by the City Accountant and the City Treasurer as enumerated in the Statement of Funding Sources (LBP Form No. 8), and which are available for Supplemental Appropriation.

SECTION 3. COMPLIANCE. -

3.1. Any change in the budget shall be in accordance with the provision of Section 321 of the Local Government Code of 1991.

3.2. Disbursement and expenditures shall comply with the budgetary requirements and limitations provided in Section 324 and Section 325 of Republic Act 7160 and all accounting and auditing rules and regulations.

3.3 Compliance to DILG Memorandum Circular No. 2011 – 134 dated September 19, 2011 on full disclosure of local budget and finance, bids, and public offerings.

SECTION 5. SEPARABILITY CLAUSE. - If for any reason any part of this ordinance shall be held unconstitutional or invalid, other parts hereof which are not affected shall continue to be in full force and effect.

SECTION 6. EFFECTIVITY. - This Ordinance shall take effect upon approval of the City Mayor.


