ORDINANCE NO. 25-038 S. 2025

AN ORDINANCE AUTHORIZING THE AUGMENTATION OF APPROPRIATIONS IN THE OFFICE OF THE CITY LEGAL OFFICER – UNDER EXPENSE CLASSIFICATION 200 - MAINTENANCE AND OTHER OPERATING EXPENSES

WHEREAS, Section 336 of the Local Government Code of 1991 states:

"Section 336. Use of Appropriated Funds and Savings. Funds shall be available exclusively for the specific purpose for which they have been appropriated. No ordinance shall be passed authorizing any transfer of appropriations from one item to another. However, the local chief executive or the presiding officer of the sanggunian concerned may, by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations."

WHEREAS, the transfer of appropriation from one item to another is allowed when the purpose of the transfer is to augment any item in the approved annual budget within the same expense class.

NOW THEREFORE, be it ordained by the Sangguniang Panlungsod of Batangas City, in Session assembled:

SECTION 1. TITLE. – This Ordinance shall be called "Authorizing the Augmentation of Appropriations in the Office of the City Legal Officer – under expense classification 200 - Maintenance and Other Operating Expenses".

SECTION 2. AUGMENTATION. – The augmentation in the Office of the City Legal Officer - under expense classification 200 was hereby approved and authorized:

SECTION 6. SEPARABILITY CLAUSE. – If for any reason any part of this ordinance shall be held unconstitutional or invalid, other parts hereof which are not affected shall continue to be in full force and effect.

SECTION 7. EFFECTIVITY. – This Ordinance shall take effect upon approval of the City Mayor.
