**APPROVING THE PROPOSED NEW SALARY LOAN PROGRAM OF THE PHILIPPINE

**WHEREAS**, the Philippine Veterans Bank is a duly authorized depository bank of the Batangas City Government and it is the drawee bank for the salaries and wages of the Batangas City government employees;

**WHEREAS**, the Philippine Veterans Bank had been providing a salary loan program to qualified employees of the City Government;

**WHEREAS**, the Philippine Veterans Bank is proposing a new salary loan program to the City Government with improved terms and conditions;

**WHEREAS**, the Sangguniang Panlungsod finds the proposed new salary loan program to be beneficial to the city government employees and will alleviate their living conditions.

**NOW THEREFORE**, be it resolved as it is hereby resolved by the Sangguniang Panlungsod in session assembled to approve as it hereby approves the proposed new salary loan program of the Philippine Veterans Bank for the Batangas City Government Employees.


