**RESOLUTION NO. 108 S. 2014**

**REINSTATING THE POSITION OF REGISTRAR III IN THE COLEGIO NG LUNGSOD NG BATANGAS AND REVOKING FOR THE PURPOSE SANGGUNIANG PANLUNGSOD RESOLUTION NO. 90 S. 2014**

**WHEREAS**, the Sangguniang Panlungsod approved Resolution No. 90 S. 2014 entitled "RESOLUTION GRANTING THE REQUEST OF THE HONORABLE CITY MAYOR EDUARDO B. DIMACUHA FOR THE ABOLITION AND CREATION OF POSITION IN THE COLEGIO NG LUNGSOD NG BATANGAS";

**WHEREAS**, by virtue of Resolution No. 90 S. 2014, the position of Registrar III (SG-18) in the Colegio ng Lungsod ng Batangas was abolished and the position of Senior Administrative Assistant V (SG-18) was created, as requested by the Honorable City Mayor;

**WHEREAS**, the College Administrator of the Colegio ng Lungsod ng Batangas now manifests that after review, the Board of Regents of the Colegio ng Lungsod ng Batangas realized that the position of Registrar III is currently the highest administrative office in the Colegio ng Lungsod ng Batangas and that the school cannot legally exist without said office;

**WHEREAS**, the Board of Regents likewise finds that a Senior Administrative Assistant V cannot perform the duties and responsibilities of the Registrar;

**WHEREAS**, there is a need to reinstate the position of REGISTRAR III (SG-18) and to revoke, for the purpose Sangguniang Panlungsod Resolution No. 90 S. 2014 which created the position of Senior Administrative Assistant V (SG-18);




