RESOLUTION NO. 111 S. 2014

**A RESOLUTION PROPOSING THE GRANT OF ALLOWANCE OR HONORARIUM
TO KALIPI BATANGAS FEDERATION OFFICERS FOR THEIR BASIC
NECESSITIES IN PERFORMING THEIR FUNCTIONS**

WHEREAS, under Section 458 (a) of the Local Government Code of 1991 the Sangguniang Panlungsod as the legislative body of the city, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the city and its inhabitants pursuant to Section 16 of the said Code;

WHEREAS, under Section 455 (a)(iii) of the Local Government Code of 1991 the City Mayor (iii) present the program of government and propose policies and projects for the consideration of the Sangguniang Panlungsod for a possible ordinance;

WHEREAS, the provision of the benefits to Barangay Officials, including Womens/KALIPI may be considered among the programs of the City Government for the welfare of barangay;

WHEREAS, under Section 458 (a) of the Local Government Code of 1991 the Sangguniang Panlungsod shall approve ordinances and pass resolutions necessary for an efficient and effective city government;

WHEREAS, KALIPI BATANGAS FEDERATION is composed of 16 Women President from different Barangay in the City of Batangas including President, Vice President, Secretary, Treasurer, Auditor, and Board of Directors;

WHEREAS, KALIPI Officers are performing different roles and responsibilities related to women empowerment such as organizing activities and projects for their members and for other constituents of their respective or other barangay;

Continuation of Resolution No. 111 S. 2014

A RESOLUTION PROPOSING THE GRANT OF ALLOWANCE OR HONORARIUM TO KALIPI BATANGAS FEDERATION OFFICERS FOR THEIR BASIC NECESSITIES IN PERFORMING THEIR FUNCTIONS

WHEREAS, their position is a voluntary position in the barangay, that does not have wages and salaries in return of their functions;

WHEREAS, they attend meetings, trainings and seminars through the City Social Welfare and Development Office for updates, schedules and activities launched and funded by the City Government or other organizations;

WHEREAS, it could be taken into consideration to allow the KALIPI Federation Officers received Allowance or Honorarium for the basic necessities in performing their functions basically for their transportation and meals;

WHEREAS, possible source of fund for their honorarium and allowance is the Gender and Development Focal Point in the City of Batangas thru the Ordinance enacted appropriating funds of 5% out of the 20% Development Fund of the City depending on the availability of funds;

NOW THEREFORE, be it resolved as it is hereby resolved by the Sangguniang Panlungsod in session assembled to propose as it hereby proposes the grant of allowance or honorarium to KALIPI Federation Officers of the City of Batangas.

RESOLVED FURTHER, that copies of this resolution be furnished to the Office of the Honorable City Mayor Eduardo B. Dimacuha, City Social Welfare and Development Office, different departments of Batangas City Government, and the 105 barangays of the City of Batangas thru the Office of the ABC President.
