ADOPTING THE REPORT OF THE COMMITTEE ON LAWS, RULES AND REGULATIONS ON THE PROPOSED ORDINANCE REGULATING THE ESTABLISHMENT OF GASOLINE STATIONS AND FILLING STATIONS OF COMBUSTIBLE MATERIALS OR PRODUCTS WITHIN THREE HUNDRED METER RADIUS FROM ANY EXISTING GASOLINE STATION OF SIMILAR NATURE AND PROVIDING PENALTY FOR VIOLATION THEREOF
