RESOLUTION NO. 152 S. 2014

URGENTLY REQUESTING THE CHIEF EXECUTIVE TO ISSUE A CEASE AND DESIST ORDER AGAINST THE START UP/COMMISSIONING OF JG SUMMIT'S NAPHTHA CRACKER PLANT IN SIMLONG, BATANGAS CITY

WHEREAS, the Sangguniang Panlungsod, is taking positive aggressive action on the clamor of the constituents of Batangas City against the environment and health dangers posed by the operation of the Naptha Cracker Plant of JG Summit in Barangay Simlong, Batangas City;

WHEREAS, investigation of the conditions of operation of the said Naptha Cracker Plant yields undeniable violations of various environmental laws, DENR issuances and of the Batangas City Environment Code;

WHEREAS, the continued activities prior to operation of Naptha Cracker Plant despite the violation of laws and the danger it poses to the health and safety of the people renders the Batangas City Government inutile in protecting its constituents and the environment;

WHEREAS, there is a compelling necessity to stop further degradation of the environment and violation of the people's right to life and property;

WHEREAS, it has been on record from the minutes of committee hearing that JG Summit's Naptha Cracker Plant admitted their lapses on their pre-operating activities that was confirmed by DENR representatives;

NOW THEREFORE, be it resolved as it is hereby resolved, to urgently request the City Chief Executive to issue a CEASE AND DESIST ORDER against the start-up commissioning of JG Summit's Naptha Cracker Plant in Simlong, Batangas City until such time that safety, security and health issues are resolved.


