RESOLUTION ALLOWING THE UTILIZATION OF THE QUICK RESPONSE FUND
IN THE AMOUNT OF FOUR HUNDRED SIXTY THOUSAND ONE HUNDRED
THIRTY FOUR PESOS (P460,134.00) FOR THE IMMEDIATE
REHABILITATION AND RECOVERY OF DAMAGED AREA IN
BARANGAY STA. CLARA, BATANGAS CITY

WHEREAS, the City Mayor, Eduardo B. Dimacuha requested for authority to use the amount of P460,134.00 from calamity fund to be contributed to Barangay Sta. Clara, Batangas City;

WHEREAS, the rehabilitation plan was agreed upon by the City Disaster Risk Reduction and Management Council;

WHEREAS, the amount requested by the City Mayor comes from the 20% Calamity Fund which is a part of Quick Response Fund;

WHEREAS, the amount requested by the City Mayor is allowed under Section 21 of RA 10121 and Rule 18 Section 1 of its Implementing Rules and Regulations which states that "Upon recommendation of the LDRRMO and approval of the Sangguniang Panlungsod concerned, the LDRRMC may transfer an amount of the LDRRM Fund to support disaster risk reduction work and other LDRRMC's which are declared under state of calamity;


