WHEREAS, the Honorable City Mayor in his letter requested for the abolition of Assistant Department Head I position (SG-23) and the creation of the following position titles: (a) 1-Supervising Environmental Management Specialist (SG-22); (b) 2-Engineering Assistant (SG-8); (c) 4-Engineering Aide (SG-4); (d) 2-Forest Ranger (SG-4) and (e) 4-Administrative Aide (SG-1) in the City Environmental and Natural Resources Office due to voluminous concerns and mandates under the E-code and other environmental laws and regulations of the said office;

NOW THEREFORE, be it resolved, as it hereby resolves, to approve the abolition of Assistant Department Head I position (SG-23) and the creation of the following position titles: (A) 1-Supervising Environmental Management Specialist (SG-22); (b) 2-Engineering Assistant (SG-8); (c) 4-Engineering Aide (SG-4); (d) 2-Forest Ranger (SG-4) and (e) 4-Administrative Aide (SG-1) in the City Environmental and Natural Resources Office.


