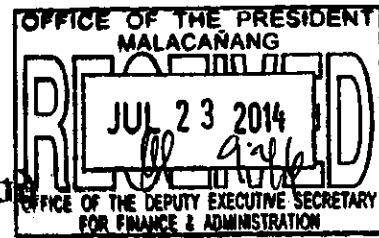

**RESOLUTION NO. 186 S. 2014**

**A RESOLUTION REQUESTING THE NATIONAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (NDRRMC) TO PRIORITIZE AND PROVIDE FUNDS FOR THE RECONSTRUCTION AND REHABILITATION OF THE CALUMPANG BRIDGE IN BATANGAS CITY**

**WHEREAS**, Batangas City was heavily affected by Typhoon Glenda;

**WHEREAS**, due to strong wind, heavy rainfall and strong river current brought about by Typhoon Glenda, one of the two main bridges, known as the Calumpang Bridge, which connects fifty-two (52) barangays to the City Proper, collapsed unexpectedly, causing severe traffic and inconvenience to affected residents of these barangays;

**WHEREAS**, the collapse of Calumpang Bridge affects not only students and commuters who have to endure a longer route to get to school but also businesses and establishments which transport products using said bridge;

**WHEREAS**, the NDRRMC plays a major role in keeping the country safe from disasters and ensuring quick recovery afterwards, and aims to restore and improve facilities, livelihood and living conditions and organizational capacities of affected communities, and reduce disaster risks in accordance with the "build back better" principle by reconstructing infrastructure and other public utilities;

**NOW THEREFORE**, be it resolved, as it is hereby resolved by the Sangguniang Panlungsod of Batangas City in session assembled to request as it hereby respectfully requests the National Disaster Risk Reduction and Management Council thru Defense Secretary Voltaire T. Gazmin for fund assistance for the reconstruction and rehabilitation of the Calumpang Bridge in Batangas City.


