**RESOLUTION NO. 199 S. 2014**

**RESOLUTION AUTHORIZING THE CITY MAYOR TO ENTER INTO A  
MEMORANDUM OF AGREEMENT WITH LANDBANK OF THE PHILIPPINES  
TO ENABLE THE CITY GOVERNMENT TO ACCEPT THE PAYMENTS  
THROUGH VALID AND EXISTING ATM/DEBIT CARDS OR PREPAID CASH  
CARD FOR LOAN AMORTIZATION USING THE POINT OF SALE TERMINAL**

**WHEREAS**, Section 24 Article II of the 1987 Philippine Constitution clearly emphasizes that the State shall recognize the vital role of Communication and Information in nation-building;

**WHEREAS**, Section 16 of RA 7160, commonly known as the General Welfare Clause of the Local Government Code of the Philippines, highlights the encouragement of the support of the development of appropriate and self-reliant scientific and technological capabilities, enhancement of economic prosperity, maintenance of peace and order and preservation of comfort and convenience of the people;

**WHEREAS**, Section 2 Part 1 of the Republic Act No. 8792 otherwise known as the "Electronic Commerce Act of 2000" emphasizes the need to create an information-friendly environment which supports and ensures the availability, diversity and affordability of Information Communication Technology (ITC) products and services;


