**A RESOLUTION DISMISSING ADMINISTRATIVE CASE NO. 02-14 FOR VIOLATION OF R.A. 9184 FILED BY COUNCILOR ANTONIO E. RIOLA AND COUNCILOR LOLINDA LILANG VERSUS BARANGAY CHAIRMAN NENELITA E. ZARASPE, AND COUNCILORS EDITHA TEGON, GREGORIO GUPIT, JERRY VILLENNA, AVELINO CATLE, LUIS SADIANGCOLOR, TREASURER EMILIANA M. FRANE AND SECRETARY CRISTINA LOPEZ ALL FROM BARANGAY PAHARANG WEST, BATANGAS CITY**

**WHEREAS**, on July 13, 2014 Barangay Councilors Antonio Riola and Lolinda Lilang filed a complaint against Barangay Chairman Nenelita E. Zaraspe and Councilors Editha Tegon, Gregorio Gupit, Jerry Villena, Avelino Catle, Luis Sadiangcolor, Treasurer Emiliana M. Frane, and Secretary Cristina Lopez for violation of R.A. 9184, also known as the Procurement Reform Act;

**WHEREAS**, the respondents submitted their verified answer on the complaint filed against them, received by the Sangguniang Panlungsod on July 17, 2014;

**WHEREAS**, the complainants filed a letter withdrawing the above-mentioned case on July 28, 2014;

**WHEREAS**, the Committee of the Whole is constrained to dismiss the Administrative Case considering the letter of withdrawal filed by the complainants;



After the referral of the complaint to the Committee of the Whole chaired by the Committee on Ethics and Good Governance for violation of R.A. 9184 or the Government Procurement Reform Act filed by Councilors Antonio Riola and Lolinda Lilang against Barangay Chairman Nenelita Zaraspe and Councilors Editha Tegon, Gregorio Gupit, Jerry Villena, Avelino Cattle, Luis Sadiangcolor, Treasurer Emiliana M. Frane and Secretary Cristina Lopez from Barangay Paharang West, the respondents were given 15 days to file answer. The Respondents submitted their verified answer on July 17, 2014, their motion for extention of time to file answer having been granted by the Committee.

After the complainants received the copy of the Answer filed by Respondents, they filed a manifestation withdrawing the complaint. 


