RESOLUTION COMMENDING MEMBERS OF THE BATANGAS CITY POLICE UNIT FOR ARRESTING ROLAND DE GRACIA LUMANGLAS, NUMBER NINE (9) IN THE TOP 10 DRUG WATCHLIST OF BATANGAS CITY PNP

WHEREAS, drug proliferation and addiction are some of the biggest problems of our country today;

WHEREAS, this social problem causes increased crime rates and even directly affects family relationships;

WHEREAS, alongside with the rapid development and industrialization, Batangas City also has its share of this vicious social disease;

WHEREAS, the Batangas City PNP has launched a continuous campaign to totally eradicate substance abuse in this city;

WHEREAS, in connection with the said PNP Drug eradication Campaign in Batangas City, said personnel launched "Case Operational Plan Bagyo", the goal of which is to arrest and bring to justice Roland De Gracia Lumanglas, a notorious drug pusher who is no. 9 in the PNP Batangas City Drug Watchlist;

WHEREAS, on or about 2 pm of January 16, 2014, the combined forces from SAID Section, Warrant Section and Special Operation Task Force (SOFT) of Batangas City PNP Headquarters arrested the said Roland De Gracia Lumanglas in Sitio Puyo, Sta. Clara, Batangas City, while in possession of numerous plastic sachets suspected to contain the substance Methamphetamine Hydrochloride, also commonly known as "shabu";

WHEREAS, the arrest of Roland De Gracia Lumanglas has drawn a visible setback in the proliferation and abuse of the abovementioned substance in this city;

WHEREAS, these PNP operatives gallantly put their lives in imminent danger while in the performance of their sworn duties;
