RESOLUTION NO. 244 S. 2014

A RESOLUTION REQUESTING THE TRANSPORTATION DEVELOPMENT AND REGULATORY OFFICE (TDRO) TO GRANT THE APPEAL OF THE PASSENGERS AND THE PUBLIC UTILITY JEEPNEY (PUJ) TRANSPORT GROUPS TO CONVEY AND LOAD PASSENGERS IN BARANGAY PALLOCAN WEST NEAR CALUMPANG RIVER, TO LOAD PASSENGERS BOUND TO BARANGAY GULOD AND DUMANTAY ALONG M. H. DEL PILAR STREET AND TO PROVIDE SUFFICIENT MEANS OF TRANSPORT TO PASSENGERS BOUND TO BARANGAY CALICANTO AND BOLBOK, SUBJECT TO TDRO REGULATIONS

WHEREAS, Section 458 of Republic Act 7160 otherwise known as the Local Government Code of 1991 provides that the Sangguniang Panlungsod as the legislative body of the City shall enact ordinances and approve resolutions for the general welfare of the City and its inhabitants pursuant to Section 16 of R.A. 7160;

WHEREAS, Section 16 of R.A. 7160 states that every local government unit shall exercise the powers which are essential to the promotion of the general welfare and the preservation of the comfort and convenience of their inhabitants;

WHEREAS, the City of Batangas is vested with a primordial duty to ensure the efficient and effective delivery of the basic services to its inhabitants which include the provision of accessible, sufficient and affordable mode of transportation in all routes and major thoroughfares in the City;

H. DEL PILAR STREET AND TO PROVIDE SUFFICIENT MEANS OF TRANSPORT TO PASSENGERS BOUND TO BARANGAY CALICANTO AND BOLBOK, SUBJECT TO TDRO REGULATIONS

WHEREAS, the collapse of the Calumpang Bridge during the onslaught of typhoon "Glenda", resulted to heavy traffic and congestion of the streets, insufficiency and unavailability of public utility jeepneys on certain thoroughfares, and costly fares due to several rides in order to go to and from the poblacion area of the City;

WHEREAS, the jeepney passengers from the barangays of Upland and Solid Baybay (excluding Libjo) and its respective transport groups are requesting the City Government as they deem it convenient, accessible and affordable to allow the PUJ plying their route to convey passengers up to the nearest point possible to Calumpang River on the side of Barangay Pallocan West where the passengers have to take a boat ride, instead of unloading the passengers at the parking space of SM City Batangas from where they have to take another ride to the River. Moreover, it is requested that during the rush hours in the afternoon, a considerable number of aforesaid concerned PUJ be allowed to park near the River to load passengers;

WHEREAS, the jeepney passengers from the barangays of Gulod and Dumantay and its respective transport groups are likewise requesting as they deem it convenient and accessible to allow the PUJ plying their route to load passengers along M.H. Del Pilar Steet from 4:00 in the afternoon to 7:00 in the evening so as to provide an organized loading area for the passengers;

WHEREAS, the jeepney passengers from the barangays of Calicanto and Bolbok are also requesting as they deem it convenient, accessible and affordable to allow the entry of PUJ's plying the route of Batangas-Rosario and Batangas-Lipa within the downtown area of the City using the Hilltop Road, down to Lawas, and right straight to Calicanto so that sufficient transportation may be provided to the barangays along said route;

WHEREAS, there is a need to address the request and sentiments of the general public specifically the commuters who experiences in a day-to-day basis the impact of the traffic situation in the City so that the City can still adhere to its duty of delivering basic services effectively, promoting the general welfare, and preserving the comfort and convenience of its inhabitants;

WHEREAS, upon deliberation and comprehensive study conducted by the Committee on Transportation through series of committee hearings, the committee finds relevant and urgent reasons to justify the approval of the request of the general public and the PUJ transport groups;


NOW THEREFORE, BE IT RESOLVED, as it hereby resolves to request the Chief Executive and the Transportation Development and Regulatory Office to grant the appeal of the passengers and the public utility jeepney (PUJ) transport groups to convey and load passengers in barangay Pallocan West near Calumpang River, to load passengers bound to barangay Gulod and Dumantay along M.H. Del Pilar Street, and to provide sufficient means of transport to passengers bound to barangay Calicanto and Bolbok, subject to TDRO regulations.

of certain basic services, capability-building and livelihood projects, and to develop local enterprises designed to improve productivity and income, diversify agriculture, spur rural industrialization, promote ecological balance, and enhance the economic and social well-being of the people.

1.3. Section 36. Assistance to People's and Non-Governmental organization. - A local government unit may, through its local chief executive and with the concurrence of the Sanggunian concerned, provide assistance, financial or otherwise for economic, socially-oriented, environmental or cultural projects to be implemented within its territorial jurisdiction.

WHEREAS, the Committee on Accreditation of the Sangguniang Panlungsod has scrutinized the papers of the NGOs and POs in order to find out whether these NGOs and POs are qualified for accreditation and membership in the Local Special Bodies;

WHEREAS, the Sangguniang Panlungsod thru the Committee on Accreditation has approved the accreditation of the following NGOs and POs as accredited NGOs and POs in the Sangguniang Panlungsod, after having found to have complied with all necessary requirements for this purpose to wit:


- a.) Sagip Tinga Falls Association, Inc.
- b.) Kayang-kaya Basta Sama-sama Foundation, Inc.

NOW THEREFORE, BE IT RESOLVED TO APPROVE, AS IT IS HEREBY APPROVED, the Application for Accreditation of the different NGOs and POs in the City of Batangas.


