the following Resolution was Adopted:

RESOLUTION NO. 262 S. 2014

**A RESOLUTION GRANTING THE HONORABLE CITY MAYOR THE AUTHORITY
TO UTILIZE THE REMAINING FIFTY PERCENT (50%) OF THE CALAMITY
FUND FOR THE IMMEDIATE REPAIR OF THE CALUMPANG DIKE AND
FURTHER DECLARING THAT THE REPAIR OF THE CALUMPANG
DIKE IS AN EMERGENCY PROJECT**

WHEREAS, the extensive damage to the dike brought about by Typhoon Glenda is a continuous threat and an imminent danger to the lives and properties of not just the people adjacent to the dike but also the residents of the Poblacion area, Barangay Gulod Labac and Pallocan West in the event of river overflow by excessive rainfall or massive flow of water from elevated areas in the province;

WHEREAS, the Sangguniang Panlungsod approved the Annual Investment Plan submitted by the City Disaster Risk Reduction Management Office (CDRRMO) includes the repair of the Calumpang Dike last September 10, 2014 wherein in the special session that transpired, it was confirmed by the City Engineer's Office that the planning and normal procurement process shall take approximately two (2) months that may result to further severe damages that will aggravate the situation;

WHEREAS, the Sangguniang Panlungsod received a letter from the Honorable City Mayor, Eduardo B. Dimacuha dated September 10, 2014 requesting the grant of authority to address the repair of the Calumpang Dike through the utilization of the remaining Fifty Percent (50%) of the Calamity Fund and to state that the said repair be considered as an emergency project;

A RESOLUTION GRANTING THE HONORABLE CITY MAYOR THE AUTHORITY TO UTILIZE THE REMAINING FIFTY PERCENT (50%) OF THE CALAMITY FUND FOR THE IMMEDIATE REPAIR OF THE CALUMPANG DIKE AND FURTHER DECLARING THAT THE REPAIR OF THE CALUMPANG DIKE IS AN EMERGENCY PROJECT

WHEREAS, the Sangguniang Panlungsod in unison authorizes the Honorable City Mayor to resort into the utilization of the remaining Fifty Percent (50%) of the Calamity Fund for the immediate repair of the Calumpang Dike for this emergency case including that of stipulated on the approved Annual Investment Plan of the City Disaster Risk Reduction Management Office (CDRRMO) allocated for the said repair of the dike as emergency project;

WHEREAS, the pictures of the actual physical structure of the dike shown on the Sangguniang Panlungsod, manifestations by members of the Sangguniang Panlungsod who were witnesses to the urgency of the situation including the statements of the Barangay Officials and residents last September 10, 2014 and the continuous damage to the dike prove that there is a sufficient and justifiable ground to justify the necessity to declare that the situation is an emergency case that requires immediate response;

NOW THEREFORE, be it resolved as it hereby resolves by the Sangguniang Panlungsod of Batangas City in session assembled to grant the Honorable City Mayor the authority to utilize the remaining Fifty Percent (50%) of the calamity fund for the immediate repair of the Calumpang Dike and further declare that the repair of the Calumpang Dike is an emergency project provided that:

- a. Measures prior to the emergency project in order to repair the Calumpang Dike be undertaken such as coordination with the Department of Public Works and Highways and/or other national agencies concerned in order to avoid and clear all legal impediments and legal issues that may arise.
- b. That status reports be submitted to the Sangguniang Panlungsod through and in coordination with the Committee on Engineering and Public Works regarding stages and up to date developments pertaining to the negotiated procurement and construction of the Calumpang Dike.
- c. That the repair of the Calumpang Dike and the utilization of the Fifty Percent (50%) of the Calamity Fund to further augment the said repair shall be in accordance with pertinent accounting and auditing laws, rules and regulations.

RESOLVED FURTHER, that copies of this resolution be sent to the Honorable City Mayor, Eduardo B. Dimacuha, City Planning and Development Office, City Engineer's Office, City Treasurer's Office and all other City Government procuring entities of the City of Batangas.


