**RESOLUTION NO. 266 S. 2014**

**APPEALING TO THE HONORABLE SENATE OF THE PHILIPPINES FOR FINANCIAL  
ASSISTANCE FOR THE CONSTRUCTION OF THE CALUMPANG BRIDGE  
AND CALUMPANG RIVER DIKE**

**WHEREAS**, Batangas City suffered a big loss due to typhoon Glenda, particularly, with the collapse of Calumpang Bridge which is a major passageway connecting the industrial and commercial zone to the poblacion and the northern part of the city and the province;

**WHEREAS**, the collapse of the said bridge caused a crisis in the life of our people, making transportation of people and goods across the Calumpang River very inconvenient, and dangerous for students and children;

**WHEREAS**, the unremoved portion of the span of the bridge which collapsed is continuously eroding the river dike, which in turn puts in peril the lives of the residents along the river bank;

**WHEREAS**, estimates of the cost of construction of a new bridge reaches almost Three Hundred Million Pesos (P300,000,000.00);

**WHEREAS**, Calumpang Bridge is a national bridge and the local government of Batangas has to seek financial assistance from national agencies to rebuild it;


