**RESOLUTION NO. 296 S.2014**

**APPROVING AND DECLARING OPERATIVE THE SUPPLEMENTAL BUDGET  
FOR CALENDAR YEAR 2014 OF BARANGAY SAN AGUSTIN SILANGAN,  
ISLA VERDE AND SAN ISIDRO, BOTH OF BATANGAS CITY**

**WHEREAS,** a review of the Supplemental Budget of Barangay San Agustin Silangan, Isla Verde and San Isidro, both of Batangas City show substantial compliance with the provisions of the Local Government Code of 1991.

**NOW THEREFORE,** be it resolved, as it hereby resolves, to approve and declare operative the Supplemental Budgets for the purpose the amount was appropriated:

1. San Agustin Silangan, Isla verde	P 50,000.00
2. San Isidro	P 70,000.00

**RESPONSIBILITY.** The execution of the budget and the accountability therefore shall be vested primarily in the Punong Barangay.

**COMPLIANCE.** Compliance to the provisions of the Budget Operations Manual for LGU's issued by the Department of Budget and Management and Commission on Audit and to all auditing rules and regulations are hereby mandated.

**EFFECTIVITY.** The approved Supplemental Budget of the barangay shall take effect upon approval by the Sangguniang Barangay concerned or on the date fixed in the Barangay Ordinance as provided in Article 416 IRR and Section 332 LGC.


