SUBJECT

Revised Portions of the City's Disaster Risk Reduction and Management Plan 2014-2016.

#### COMMENTS:

On September 8, 2014 the Sangguniang Panlungsod referred to the Committee on Laws, Rules and Regulations the letter of the Honorable City Mayor dated September 1, 2014, the revised portions of the City's Disaster Risk Reduction and Management Plan 2014-2016 for study, comment and recommendation.

After the referral to the aforementioned committee, the Committee conducted a committee hearing on October 14, 2014.

Present during the committee hearing were the Chairman of Committee on Laws, Rules and Regulations Councilor Alyssa Cruz-Atienza, Councilor Sergie Rex M. Atienza and Councilor Ma. Claudette Ambida-Alday, members. Also present was Mr. Rodrigo D. Dela Roca, CDRRM Officer.

The revised portions of the City's Disaster Risk Reduction and Management Plan 2014-2016 have the following revisions:

- Amended Executive Order 19 with Executive Order 28 which now included Youth Organization (Replacing SK Federation President), Women's Organization, Religious Organization, Senior Citizen's Organization and Persons-With-Disability Organizations, as well as Private Organizations such as Batangas City water District, SM City Batangas, PPA, ATI, and FPIC.
- Executive Order 28 also specifies the persons in charge for each committee of each thematic area, as well as their sub-committees and their contact numbers to enable the council to contact them immediately during any eventuality.
- 3. Specified the membership of Sanggunian in the CDRRM council's structure.
- The committees now include the City Legal Officer as legal intervention / advisory, SP Chairman for Public Safety and Fire, Youth, Women's, Religious, Senior Citizen's and PWD Organizations, and Private Organizations.
- 5. The Sectoral Functions were also revised to reflect the functions of each committee and member agency before, during and after the calamity.

### RECOMMENDATION:

Finding the revised portion of CDRRMC Plan 2014-2016 in accordance with law and responsive to the needs of Batangas City in terms of disaster risk reduction / protection, the Committee recommends:

- The adoption of this Committee Report
- 2. The approval of the required Resolution hereto attached.
