APPROVING ON FIRST READING THE PROPOSED ORDINANCE ENTITLED: "AN ORDINANCE REQUIRING ALL ESTABLISHMENTS WITHIN THE JURISDICTION OF THE CITY OF BATANGAS WHETHER FOR PROFIT OR NOT AND WHICH ARE OPERATING PUBLIC TOILETS, TO INSTALL BIDET SPRAYS/HOSES ON SUCH PUBLIC TOILETS, IMPOSING PENALTIES FOR VIOLATIONS THEREOF AND PROVIDING FUNDS THEREFOR AND FOR OTHER PURPOSES

RESOLVED, to approve on first reading the title of the proposed ordinance entitled: "An Ordinance Requiring All Establishments Within the Jurisdiction of the City of Batangas Whether For Profit or Not And Which Are Operating Public Toilets, To Install Bidet Sprays/Hoses On Such Public Toilets, Imposing Penalties For Violations Thereof And Providing Funds Therefor And For Other Purposes."
