**APPROVING AND DECLARING OPERATIVE THE SUPPLEMENTAL BUDGET FOR
CALENDAR YEAR 2014 OF DIFFERENT BARANGAYS OF BATANGAS CITY**

WHEREAS, a review of the Supplemental Budget of Barangays Poblacion 13, Poblacion 23, Libjo, Pinamukan Proper and Sirang Lupa, all of Batangas City show substantial compliance with the provisions of the Local Government Code of 1991.


Certified copy of this resolution shall immediately be furnished to the concerned Sangguniang Barangay, through the Punong Barangay and to the City Budget Officer.
