

THE REQUEST OF ABAKA


RESOLVED, to refer to the Joint Committees on Barangay

SUBJECT :

1. Barangay Ordinance Blg. 1 Serye 2014 "Pagpapabuwis sa Lahat ng Negosyo at Gawain sa Nazasakupan ng Tinga Labac, Lungsod ng Batangas."
2. Ordinansang Pambarangay Blg. \_\_\_ Serye 2014 ng Barangay Talahib Pandayan, Batangas City, "Pagpapabuwis sa Lahat ng Negosyo at Gawain sa Nazasakupan ng Barangay".

On February 3, 2014, the above-mentioned ordinances of Barangay Tinga Labac and Talahib Pandayan were referred to the Committees on Barangay Affairs and Laws, Rules and Regulations for further study, comments and recommendations.

After the referral to the sforementioned committees, a joint committee hearing was conducted on February 13, 2014 at 9:00 o'clock in the morning at the Sangguniang Panlungsod Session Hall. Said committee hearing was attended by the following:

1. Barangay Captain, Marcelino Telegatos, Barangay Councilors and Treasurer of Barangay Tinga Labac, Batangas City
2. Barangay Treasurer of Talahib Pandayan.
3. Mrs. Ditas Rivera (BPLO Officer of Batangas City)
4. Coun. Glenn Aldover
5. Coun. Armando Lazarte
6. Coun. Claudette Ambida

FINDINGS:

Section 129 of the Local Government Code (LGC) gives power to the barangays to create its own sources of revenue and to levy taxes, fees and charges subject to certain limitations as provided for in the code.

The ordinance of Barangay Tinga Labac has complied with the limitations on taxing powers and revenue measure as provided for in Sections 130 and 133 of the LGC. Therefore, the committee finds the said ordinance consistent with existing laws, rules and regulations.

On the other hand, the ordinance of Barangay Talahib Pandayan has to be revised to correct certain provisions to make them conform with the limitations provided for by the Local Government Code of 1991. Also, the ordinance has to be corrected as to form.


**RECOMMENDATIONS:**


After review of each of the barangay ordinances, the joint committees recommend the following:


1. Adoption of this Committee Report.

3. The ordinance of Barangay Talahib Pandayan be returned to the Sangguniang Barangay for revision.






