RESOLUTION NO. 91 S. 2014

RESOLUTION EXPRESSING SUPPORT TO SENATE BILL NO. 2045

WHEREAS, Senator Aquilino "Koko" Pimentel, Jr. is currently sponsoring Senate Bill No. 2045 that will benefit the LGUs by increasing their share from the Internal Revenue Allotment (IRA) from the present 40% to 50%. This will in turn result to additional fund for LGUs to appropriate for development projects;

WHEREAS, the Senate Bill proposes to broaden the sources of internal revenue fund to cushion the effect of the proposed increased share;


WHEREAS, the proposed bill will definitely redound to the benefit of LGUs like Batangas City.

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, to support the request of the Sangguniang Panlungsod of Zamboanga for the passage of Senate Bill No. 2045 authored by Senator Aquilino "Koko" Pimentel, Jr.


