
**REFERRING TO THE COMMITTEE ON APPROPRIATIONS DIFFERENT

RESOLVED, to refer to the Committee on Appropriations for further study, comments and recommendation the following:


1. Proposed Supplemental Budget No. 1 for Calendar Year 2014 of the City Government of Batangas in the amount of P281,142,366.49.
