WHEREAS, on March 12, 2015, the Honorable City Mayor requested for the authority to sign a Memorandum of Agreement between the City Government and the Local Government Academy (LGA);

WHEREAS, the City Mayor needs an authority to sign an agreement for the implementation of the Millennium Development Goals – Family Based Actions for Children and their Environs in the Slums (MDG-FACES) Project.


