**RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR TO ENTER INTO A
MEMORANDUM OF AGREEMENT WITH THE DA-REGIONAL FIELD OFFICE IV-A AND
THE REGIONAL AGRICULTURAL AND FISHERY COUNCIL (RAFC) REGARDING AN
ORGANIC FARMING FOR BOTTOMS UP BUDGET 2015**

WHEREAS, the Aquino Administration shall pursue the Philippine Millennium Development Goal (PMDG) of reducing poverty from 33.1% in the 1991 to 16.6% by 2015. This is likewise reflected in Executive Order No. 45, Series of 2011 and the Philippine Development Plan for 2011 – 2016;

WHEREAS, Executive Order No. 43 Series of 2011 enjoins all department and agencies to orient their programs, projects and activities towards the pursuit of five (5) Key Results Areas that include Poverty Reduction and Empowerment of the Poor and Vulnerable;

WHEREAS, a well thought strategy to reduce poverty incidence in the country is the implementation of Bottom Up Budgeting (BuB) that aims to ensure the inclusion of the funding requirements for the development needs of the poorest municipalities and cities in the program and budgets of National Government Agencies (NGA);

WHEREAS, the Department of Agriculture (DA) is one of the NGAs participating agencies as identified in the DBM-DILG-DSWD-NAPC JMC No. 6, Series of 2015 dated February 27, 2015 re: Policy Guidelines and Procedures in the Implementation of the Bottom-up Budgeting Projects for FY 2015;

WHEREAS, the DA-RFOIV-A supports and undertakes activities to assist and promote the development of the agriculture and fishery postharvest industries in the countryside;

WHEREAS, the Organic Farming at Batangas City is envisioned to enhance the Agricultural Production Introducing the values of basic food production, health food system and clean urban environment.



Referred to the Committee on Laws, Rules and Regulations is the above request for study, comment and recommendation.


Finding no legal impediment with the subject, and finding that the project would be beneficial to the City Government, the Committee recommends:
